

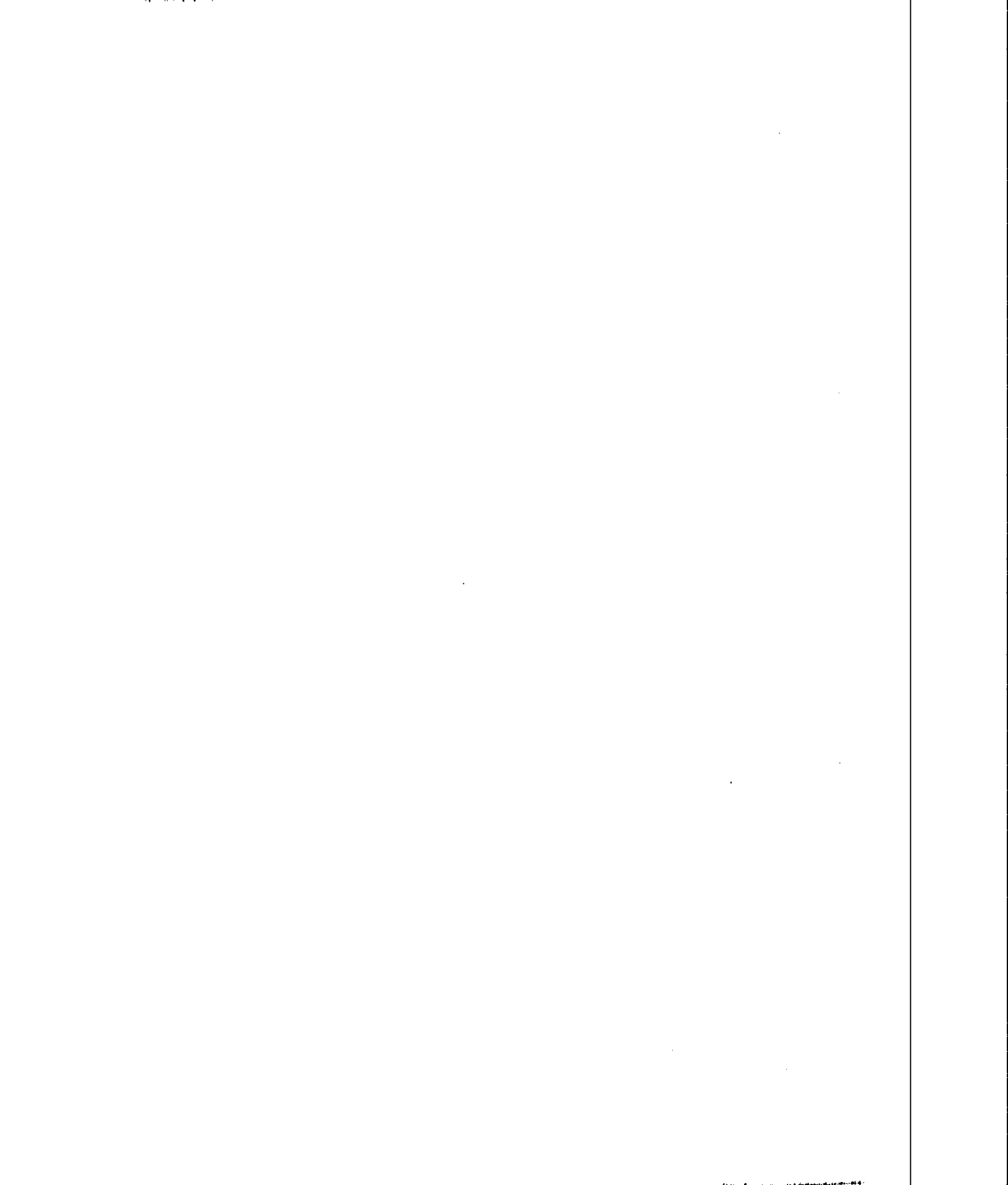
**THE CUSTOMS AND EXCISE (AMENDMENT) BILL,  
2012**

**MEMORANDUM**

The object of this Bill is to amend the Customs and Excise Act so as to—

- (a) remove duty on railway locomotives and water vessels;
- (b) remove duty on equipment, plant and machinery;
- (c) remove duty on cameras specially designed for medical or surgical examination of internal organs and comparison cameras for forensic or criminological purposes;
- (d) remove duty on instruments, appliances and furniture used in medical, surgical, dental or veterinary sciences;
- (e) remove duty on ambulances, motor cycles and engines;
- (f) remove excise duty on water and aerated artificial water;
- (g) remove duty on cooking appliances and other plate warmers that use gas fuel other than electric energy;
- (h) revise the rates of customs and excise duty payable on certain goods; and
- (i) provide for matters connected with, or incidental to, the foregoing.
