ENTITLED

An Act to continue the existence of the Zambia Development Agency and re-define its functions; re-constitute the Board of the Agency and provide for its functions; repeal and replace the Zambia Development Agency Act, 2006; and provide for matters connected with, or incidental to, the foregoing.

ENACTED by the Parliament of Zambia.

Enactment

PART I

PRELIMINARY

1. This Act may be cited as the Zambia Development Agency Short title and Act, 2022, and shall come into operation on the date appointed by commencement the Minister by statutory instrument. In this Act, unless the context otherwise requires— Interpretation "Agency" means the Zambia Development Agency continued under section 3; 10 "associate" has the meaning assigned to the word in the Anti-Act No. 3 of Corruption Act, 2012; 2012 "Board" means the Board of the Agency constituted under section 6; "business" has the meaning assigned to the word in the Act No. 3 of 15 Business Regulatory Act, 2014; "business development services" include advisory services, promoting training and financing, facilitating the preparation of business plans, project proposals, loan applications, financial statements, audited statements of 20 expenditure and income, and other similar services;

THE ZAMBIA DEVELOPMENT AGENCY

The Zambia Development Agency established under the repealed Act is continued as if established under this Act and is a 10 body corporate with perpetual succession and a common seal, capable of suing and being sued in its corporate name and with power, subject to the provisions of this Act, to do all acts and things that a body corporate may, by law, do or perform.

Continuation of Zambia Development Agency

4. (1) The seal of the Agency shall be a device that may be 15 determined by the Board and shall be kept by the Director-General.

Seal of Agency

- The affixing of the seal shall be authenticated by the Chairperson or the Vice-Chairperson and the Director-General or any other person authorised in that behalf by a resolution of the Board.
- 20 (3) A contract or instrument which, if entered into or executed by a person not being a body corporate, is not required to be under seal, may be entered into or executed without seal on behalf of the Agency by the Director-General or any other person authorised in that behalf by a resolution of the Board.
- A document purporting to be a document under the seal of 25 the Agency or issued on behalf of the Agency shall be received in evidence and shall be considered to be so executed or issued, without further proof, unless the contrary is proved.
- The Agency shall further the economic development 30 of the Republic through the promotion and facilitation of investment, domestic and foreign trade, competitiveness in business development and the privatisation of state owned enterprises.

Functions of Agency

- (2) Despite the generality of subsection (1), the functions of the Agency are to —
- (a) issue licences, permits or certificate of registration under 35 the Investment, Trade and Business Development Act, 2022;

8. (1) A member of the Board shall, subject to the other provisions of this Act, hold office for a term of three years and may be re appointed for a further and final term of three years.

Tenure of office and vacancy of member

- (2) A member shall, on the expiration of the period for which
 5 that member is appointed, continue to hold office until a successor is appointed, but in no case shall the further period exceed three months.
 - (3) The office of a member becomes vacant if that member
 - (a) dies;
- 10 (b) is adjudged bankrupt;
 - (c) is absent from three consecutive meetings of the Board of which the member has had notice, without the prior approval of the Board;
 - (d) resigns, on giving one month's notice to the Minister;
- 15 (e) is legally disqualified from performing the functions of a member;
 - (f) ceases to be a member of the Ministry, institution or organisation which nominated the member; or
- 20 is convicted of an offence under any other written law and sentenced to imprisonment for a term exceeding six months without the option of a fine.
- (4) The Minister shall, where the office of a member becomes vacant before the expiry of the term of office, appoint another member in place of that member, but that member shall hold office
 25 as a member only for the unexpired part of the term of the Board.
 - **9.** (1) Subject to the other provisions of this Act, the Board may regulate its own procedure.

Proceedings of Board

- (2) The Board shall meet for the transaction of business at least once in every three months at a place and time that the Board30 may determine.
- (3) The Chairperson shall, on giving notice of not less than seven days, call for a meeting of the Board, or where one third or more of the members so request, in writing, except that if the urgency of a particular matter does not permit the giving of a notice,
 35 a special meeting may be called on giving a shorter notice.
 - (4) Five members shall form a quorum at the meeting of the Board.

- (5) There shall preside at a meeting of the Board—
 - (a) the Chairperson;
 - (b) in the absence of the Chairperson, the Vice-Chairperson; or
 - (c) in the absence of the Chairperson and the Vice-Chairperson, a member of the Board that the members present may elect from among themselves for the purpose of that meeting.
- (6) A decision of the Board on any question shall be by a majority of votes of the members present and voting at the meeting and, in the event of an equality of votes, the person presiding at the meeting shall have a casting vote, in addition to that person's deliberative vote.
- (7) A member may, where the member is for any reason unable to attend a meeting of the Board, nominate another person in writing, from the same ministry, institution, organisation to attend a meeting of the Board in that member's stead and that person shall be deemed to be a member for the purpose of that meeting.
- (8) The Board may invite a person whose presence is, in its opinion, desirable to attend and participate in the deliberations of the meeting but that person shall have no vote.
- (9) The Board shall cause to be kept minutes of the proceedings of every meeting of the Board and any committee established by the Board.

Committees of Board

- **10.** (1) The Board may, for the purpose of performing its functions under this Act, constitute a committee and delegate any of its functions to the committee as it considers necessary.
- (2) The Board may appoint, as members of a committee, persons who are or are not members of the Board, except that at least one member of the Board shall be a member of a committee.
- (3) A committee shall have the power to invite any person whose presence, in its opinion, is desirable to attend and participate in the deliberations of the meeting of the Committee but that person shall have no vote.
- (4) A member of a committee shall hold office for a period 35 that the Board may determine.

- Subject to any specific or general direction of the Board, a committee constituted under this section may regulate its own procedure.
- 11. A member of the Board or any committee of the Board shall be paid allowances that the Emoluments Commission may, on the recommendation of the Minister, determine.

Allowances

12. (1) A person who is present at a meeting of the Board or a committee of the Board at which any matter is the subject of consideration, and in which matter that person or that person's 10 relative or associate is directly or indirectly interested in a private capacity, shall, as soon as practicable after the commencement of the meeting, declare the interest and shall not, unless the Board or the committee otherwise directs, take part in any consideration or discussion of, or vote on, any question relating to that matter.

Disclosure of interest

- 15 (2) A disclosure of interest made under this section shall be recorded in the minutes of the meeting at which the disclosure is made.
 - **13.** (1) The Board shall appoint a Director General, who shall be —

Director-General. Secretary and other staff

- the chief executive officer of the Agency; and 20 (a)
 - responsible for the day-to-day administration of the Agency under the direction of the Board.
- The Director-General shall attend meetings of the Board or a committee of the Board and may address those meetings, but shall have no vote.
 - The Board may appoint a Secretary and other staff that the Board considers necessary for the performance of the functions of the Agency.
- The Emoluments Commission shall, on the 30 recommendation of the Board, determined the emoluments of the Director-General, Secretary and other staff of the Agency.
 - The Board shall determine the terms and conditions of service, other than emoluments of the Director-General, Secretary and other staff of the Agency.

PART III

FINANCIAL PROVISIONS

Funds	of
Agenc	v

14. (1) The funds of the Agency consists of monies that may-

- be appropriated by Parliament; (a)

5

- be paid to the Agency by way of levies, fees, grants or donations; or
- vest in, or accrue to, the Agency.
- The Agency may
 - accept monies by way of grants or donations from any source in the Republic and subject to the approval of the Minister from any source outside the Republic;
 - subject to the approval of the Minister responsible for finance, raise by way of loans or otherwise, monies that the Agency may require for the discharge of the Agency's functions; or
- 15
- in accordance with the regulations made under this Act, charge and collect fees for services provided by the Agency.
- There shall be paid from the funds of the Agency—

20

- the salaries, allowances, loans gratuities and pensions of the staff of the Agency and other payments for the recruitment and retention of staff;
- reasonable traveling, and other allowances for members of the Board or members of a committee of the Board when engaged in the business of the Agency at rates that the Emoluments Commissions may, on recommendation of the Minister, determine; and
- any other expenses incurred by the Agency in the performance of the Agency's functions.

Act No. 1 of 2018

Subject to the Public Finance Management Act, 2018, the Board may, subject to the approval of the Minister, invest in a manner that the Board considers necessary any of the Agency's funds that the Agency does not immediately require for the performance of the Agency's functions.

Financial year

15. The financial year of the Agency shall be a period of twelve months ending on 31st December in each year.

- The Board shall cause to be kept proper books of accounts and other records relating to the Agency's accounts.
- (2) The accounts of the Agency shall be audited annually by the Auditor-General or an auditor appointed by the Auditor-5 General.
 - (3) The fees for the Auditor-General or an auditor appointed by the Auditor-General shall be paid by the Agency.
- 17. (1) The Board shall, as soon as practicable, but not later than ninety days after the end of a financial year, submit to the 10 Minister a report concerning the functions and activities of the Agency during the financial year.

Annual report

- The report referred to in subsection (1) shall include information on the financial affairs of the Agency and there shall be appended to the report—
- 15 an audited statement of financial position;

20

- an audited statement of comprehensive income and expenditure;
- a statement specifying the functions of the Agency and the impact of the functions on business development; and

other information that the Minister may require.

The Minister shall, not later than seven days after the first sitting of the National Assembly next after receipt of the report referred to in subsection (1), lay the report before the National 25 Assembly.

PART IV

GENERAL PROVISIONS

18. An action or other proceedings shall not lie or be instituted against a member of the Board, a member of a committee of the 30 Board or a member of staff of the Agency, for or in respect of any act or thing done or omitted to be done in good faith in the exercise or performance of any of the powers, functions or duties conferred under this Act.

Immunity

19. (1) A person shall not, without the consent in writing 35 given by or on behalf of the Agency or as otherwise permitted by any written law, publish or disclose to a person, other than in the course of that person's duties, the contents of a document, communication or information, which relates to, or which has come to that person's knowledge in the course of that person's 40 duties under this Act.

Prohibition publication or disclosure information unauthorised person

- (2) A person who contravenes subsection (1) commits an offence and is liable, on conviction, to a fine not exceeding two hundred thousand penalty units or to imprisonment for a term not exceeding two years, or to both.
- (3) A person who, having information which to the knowledge of that person has been published or disclosed in contravention of subsection (1), unlawfully publishes or communicates that information to another person, commits an offence and is liable, on conviction, to a fine not exceeding two hundred thousand penalty units or to imprisonment for a term not exceeding two years, or to both.

Immunity from execution of judgments against Agency assets **20.** Where a judgment or court order is obtained against the Agency, execution, attachment or process of any nature, shall not be issued against the Agency or against any property of the Agency, but the Agency shall cause to be paid out of the Agency's funds an amount that may, by judgment or court order, be awarded against the Agency to the person entitled to the amount.

Offences by principal officers of body corporate or unincorporate body 21. Where an offence under this Act is committed by a body corporate or unincorporate body, with the knowledge, consent or connivance of a director, manager or shareholder of that body corporate or unincorporate body, that director, manager or shareholder is liable, on conviction, to the penalty specified for the offence.

Regulations

- 22. (1) The Minister may, in consultation with the Agency, by statutory instrument, make Regulations for the better carrying out of the provisions of this Act.
- (2) Despite subsection (1), Regulations under subsection (1) may provide for
 - (a) different provisions in respect of different types of business development and sectors of trade and industry; and
 - (b) the collection of data on industry and the procedure for that collection.

Repeal of Act No. 11 of 2006

- **23.** (1) The Zambia Development Agency Act, 2006, is repealed.
- (2) Despite subsection (1), the Schedule applies to the savings and transitional provisions.

SCHEDULE

(Section 23 (2))

SAVINGS AND TRANSITIONAL PROVISIONS

1. For the purposes of this Schedule, "former Agency" means the Zambia Development Agency established under the repealed Act.

Interpretation

A person who, before the commencement of this Act, was an officer or employee of the former Agency shall continue to be an officer or employee of the Agency, as if appointed or employed under this Act.

Staff of former Agency

- The service of the persons referred to in subparagraph (1) shall be treated as continuous service.
- (3) Nothing in the Act affects the rights and liabilities of any person employed or appointed by the former Agency before the commencement of this Act.
- 3. A person who immediately before the commencement of this Act held office as a member of the Board of the former Agency shall continue to hold office as a member for a period of three months after which the Minister shall appoint the members of the Board in accordance with this Act.

Member

(1) On or after the commencement of this Act, there shall be transferred to, vest in and subsist against the Agency by virtue of this Act and without further assurance, the assets, rights and obligations which immediately before the commencement of this 25 Act were the assets, rights, liabilities and obligations of the former Agency.

Transfer of assets and liabilities

- (2) Subject to subparagraph (1), every deed, bond and agreement, other than an agreement for personnel service, to which the former Agency was a party immediately before the commencement of this Act whether or not of a nature that rights, liabilities and obligations could be assigned, shall, unless its subject matter or terms make it impossible that it should have effect as modified, as provided under this paragraph, have effect as if
 - the Agency had been party to it;
 - for any reference to the former Agency there was substituted, with respect to anything falling to be done on or after the commencement of this Act, a reference to the Agency; or

(c) for any reference to any officer of the former Agency not being a party to it and beneficially interested therein, there were substituted, with respect to anything required to be done on or after the commencement of this Act, a reference to such officer of the Agency as the Agency shall designate.

(3) Where under this Act, any assets, rights, liabilities and obligations of the former Agency are considered to be transferred to the Agency in respect of which transfer a written law provides for registration, the Agency shall make an application, in writing, to the appropriate registration authority for registration of the transfer.

(4) The registration authority, referred to in subparagraph (3), shall make entries in the appropriate register that shall give effect to the transfer and, where applicable, issue to the transferee concerned a certificate of title in respect of the property or make necessary amendments to the register and shall endorse on the deeds relating to the title, right or obligation concerned and no registration fees or other duties shall be payable in respect of the transaction.

Legal proceedings

- **5.** (1) Any legal proceedings or application of the former Agency pending immediately before the commencement of this Act by or against the former Agency, may be continued by or against the Agency.
- (2) After the commencement of this Act, proceedings in 25 respect of any right, liability or obligation which was vested in, held, enjoyed, incurred or suffered by the former Agency, may be instituted by or against the Agency.
