ENTITLED

An Act to amend the Zambia Chartered Institute of Logistics and Transport Act, 2014.

ENACTED by the Parliament of Zambia.

Enactment

1. This Act may be cited as the Zambia Chartered Institute of
Logistics and Transport (Amendment) Act, 2021, and shall be read
as one with the Zambia Chartered Institute of Logistics and
Transport Act, 2014, in this Act referred to as the principal Act.
