Madam,

The Parliamentary Select Committee was appointed on 20<sup>th</sup>May, 2022, to scrutinise the Presidential appointment of Judge Prisca Matimba Nyambe (Rtd) and Mr Chad Himoonga Muleza to serve as members of the Judicial Complaints Commission (JCC), Mr Musa Mwenye SC, Mrs Irene Musonda Chongo Lamba, Dr Henry Bwanga Mbushi and Dr O'brien Kaaba to serve as Chairperson and members of the Anti-Corruption Commission Board, respectively, and Mr Gilbert Andford Phiri to serve as Director-General of the Anti-Corruption Commission (ACC), and Dr Pamela Towela Sambo, Revd Canon Emmanuel Yona Chikoya, Mr Tom Trevor Shamakamba, Ms Laura Mary Miti and Ms Christine Chama to serve as Vice-Chairperson and Commissioners of the Human Rights Commission (HRC) respectively.

The appointment of Judge Prisca Matimba Nyambe (Rtd) and Mr Chad Himoonga Muleza to serve as members of the Judicial Complaints Commission is made pursuant to Section 20 of the Judicial Code of Conduct Act No. 13 of 1999, which provides as follows:

**"20**. (1) There is hereby constituted the Judicial Complaints Authority which shall consist of five members who have held or are qualified to hold high judicial office.

(2) The members of the Authority shall be appointed by the President subject to ratification by the National Assembly."

The appointment of Mr Musa Mwenye, SC, Mrs Irene Musonda Chongo Lamba, Dr Henry Bwanga Mbushi and Dr O'brien Kaaba to serve as Chairperson and members of the Anti-

Corruption Commission Board, respectively is made pursuant to Paragraph 2 of the Schedule, to the Anti-Corruption Act No 3 of 2012, which provides as follows:

2. (1) There is hereby constituted a Board of Commissioners which shall be the governing body of the Commission.

(2) The Board shall consist of the following Commissioners:

(a) the Chairperson, who shall be a person who has held, or is qualified to hold, high judicial office;

(b) the Vice-Chairperson; and

(c) three other persons.

(3) The Commissioners shall be appointed by the President, subject to ratification by the National Assembly."

The appointment of Mr Gilbert Andford Phiri to serve as Director-General of the Anti-Corruption is made pursuant to Section 9 of the Anti-Corruption Act No 3 of 2012, which provides as follows:

"9.(1) There shall be a Director-General of the Commission who shall be the chief executive officer of the Commission.

(2) The Director-General shall be appointed by the President, subject to ratification by the National Assembly, on such terms and conditions as the President may determine."

Lastly, the appointment of Dr Pamela Towela Sambo, Revd Canon Emmanuel Yona Chikoya, Mr Tom Trevor Shamakamba, Ms Laura Mary Miti and Ms Christine Chama to serve as Vice-Chairperson and Commissioners of the Human Rights Commission (HRC) respectively, is made pursuant to Section 5 of the Human Rights Commission Act No 39 of 1996, which provides that-

"5. (1) The Commission shall consist of the following Commissioners:
(a) the Chairperson;
(b) the Vice-Chairperson; and
(c) not more than five other Commissioners.
(2) The Commissioners shall be appointed by the President, subject to ratification by the National Assembly.
(3) The Chairperson and Vice-Chairperson shall be persons who have held, or are

qualified to hold, high judicial office.

### **TERM OF REFERENCE**

2. The Term of Reference of the Committee was to scrutinise the Presidential appointment of Judge Prisca Matimba Nyambe (Rtd) and Mr Chad Himoonga Muleza to serve as members of the JCC, Mr Musa Mwenye SC, Mrs Irene Musonda Chongo Lamba, Dr Henry Bwanga Mbushi and Dr O'brien Kaaba to serve as Chairperson and members of the ACC Board, respectively, and Mr Gilbert Andford Phiri to serve as Director-General of the ACC, and Dr Pamela Towela Sambo, Revd Canon Emmanuel Yona Chikoya, Mr Tom Trevor Shamakamba, Ms Laura Mary Miti and Ms Christine Chama to serve as Vice-Chairperson and Commissioners of the HRC, respectively.

# **MEETINGS OF THE COMMITTEE**

**4.** The Committee held a total of ten (10) meetings during the period 23<sup>rd</sup> May, 2022 to 20<sup>th</sup> June, 2022. At its First Meeting held on Monday, 23<sup>rd</sup> May, 2022, the Committee elected, Mr R Kang'ombe, MP, as Chairperson and Ms S Mwamba, MP, as Vice-Chairperson.

# **PROCEDURE ADOPTED**

**5.** The Judicial Complaints Commission is a body established under Article 236 of the Constitution, Chapter 1 of the Laws of Zambia, to enforce the code of conduct for judges and judicial officers and ensure that they are accountable to the people for the performance of their functions. In that regard, members of the JCC receive, investigate and hear complaints of misconduct against judges and judicial officers, and make recommendations on the appropriate action to be taken.

Members of the JCC play an important role in the administration and dispensation of justice in the country. As a result, the office is crucial to effective governance and the rule of law. Therefore, persons appointed to serve as members of the JCC should possess the highest ethical standards and professionalism in order to provide effective oversight of judicial officers in the performance of their duties to the public.

The Anti-Corruption Commission is mandated, under the Anti-Corruption Act, to spearhead the fight against corruption in the country. Therefore, the Commission investigates and prosecutes cases of corruption; disseminates information on the ills of corruption; advises public and private bodies on ways of preventing corruption; and creates committees in institutions for the prevention of corruption. As a result, the ACC plays a pivotal role in ensuring good governance in the country.

Therefore, the Committee resolved that only persons with a high level of integrity, ethics and professionalism should be appointed to the ACC. This was because only such people would be able drive the fight against corruption without fear or favour, strengthen the operations of the ACC and foster a culture of zero tolerance to corruption.

Further, Article 230 (1) of the Constitution establishes the Human Rights Commission (HRC), which is an integral part of Zambia's democratic dispensation. Its primary mandate is

to safeguard and promote human rights in Zambia in accordance with the Constitution, the Human Rights Commission Act and regional and international human rights conventions and protocols to which Zambia is a party.

In view of the above, it is imperative that persons appointed to the position of Vice-Chairperson and members of the HRC are persons with good knowledge and experience in human rights. Additionally, they should be able to add value to the operations of the HRC and spearhead the effective and efficient execution of its mandate.

Therefore, the Committee carefully selected the witnesses to assist it in the scrutiny of the nominees. The Committee requested memoranda from the state security agencies, relevant professional bodies and the Appointing Authority. The witnesses also appeared before the Committee to make their oral submissions. Further, the Committee assessed the suitability of the nominees to serve in the various appointments by scrutinising, in detail, their *curricula vitae* and the information submitted to the Committee by the witnesses.

# SUBMISSIONS BY STATE SECURITY AGENCIES

# ZAMBIA POLICE SERVICE (ZP)

**6.** The Deputy Inspector-General in charge of administration submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*.

The Deputy Inspector-General informed the Committee that a search conducted on its Criminal Record data base had not found any criminal or adverse record against the nominees. In that regard, ZP, found the nominees suitable for appointment to their respective positions.

## **ANTI-CORRUPTION COMMISSION (ACC)**

7. The Acting Director-General of the ACC submitted on the personal, educational and professional background of the nominees as contained in their *curricula vitae*.

The Acting Director-General stated that the ACC's submission was in line with its mandate as set out in the Anti-Corruption Act. He added that the information obtained on the nominees was based on the ACC's database, which was a computerised database called the Case Management System. The Acting Director-General explained that the system stored information relating to any investigations the ACC had handled. The information included details of the suspect, the nature of the allegation against them and the outcome and conclusion of the matter.

The Acting Director-General submitted that a search on the ACC's database had not yielded any adverse record against any of the nominees. In view of this, the ACC supported their appointment to their respective positions.

## DRUG ENFORCEMENT COMMISSION (DEC)

**8.** The Deputy Director-General submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*.

The Deputy Director-General informed the Committee that DEC searched its database to determine whether nominees had contravened the Narcotic Drugs and Psychotropic Substances Act, No 35 of 2021 or the Prohibition and Prevention of Money Laundering Act No.44 of 2010.

The Deputy Director-General submitted that a record search conducted by DEC on the nominees had not yielded any adverse record against them. In that regard, she submitted that the nominees were suitably qualified for appointment to serve in the positions they had been appointed to.

### SUBMISSIONS BY PROFESSIONAL BODIES/STAKEHOLDER INSTITUTIONS

## FINANCIAL INTELLIGENCE CENTRE (FIC)

**9.** The Director Compliance and Prevention informed the Committee that FIC had considered the legal framework that provided for the appointment of the nominees. He added that the institution had also conducted background checks on each of the nominees on its database. He submitted that a check on the personal, business and professional associations of the nominees on its database had not revealed any adverse information on them. Further it had not established any *prima facie* questionable business interests linked to any of them, which could preclude them from being appointed to their respective positions.

The Director Compliance and Prevention submitted that there were no pending suspicious transaction reports (STRs) or criminal records pertaining to the nominees.

The Director Compliance and Prevention concluded his submission by stating that FIC had no adverse record against all the nominees and, therefore, supported the appointments.

## HUMAN RIGHTS COMMISSION (HRC)

**10.** The Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. She further submitted on each of the nominees as set out below.

### (i) Judge Prisca Matimba Nyambe (Rtd)

The nominee had served under various positions of high judicial office, among them; Judge of the High Court for Zambia and elected Judge of the Residual Mechanism for International Tribunals. The nominee was a recognised senior member of the Zambian Bar, having been bestowed with the honour, dignity and rank of State Counsel and having served in various capacities in the legal profession, including as Vice-Chairperson of the Law Association of Zambia (LAZ).

As State Counsel, and former Judge of the High Court for Zambia, the nominee commanded the dignity and respect of the legal profession from the both the Bar and Bench. The nominee's track record would not only inspire confidence in the JCC, but equally serve as a benchmark for professional standards and ethics expected of judges and judicial officers. Additionally, the nominee had acquired experience and training in judicial administration having served as project leader under the Judiciary's initiative to extend jurisdiction on serious economic crimes and corruption cases from the Magistrates Courts to the High Court.

In that regard, the HRC had no reservations about the nominee's appointment.

## (ii) Mr Chad Himoonga Muleza

The nominee was a legal practitioner with over thirty (30) years of experience at the Zambian Bar having been admitted to practice as an advocate in December, 1981. The nominee satisfied the requirement for appointment because he qualified to hold high judicial office in accordance with the relevant law.

The nominee had acquired a wealth of experience by practising in various areas of the law such as litigation, taxation, securities and banking, among others. The nominee had, over the years, embraced the practice of mentoring young advocates some of whom had gone on to serve as judges of the High Court and Constitutional Court. In view of his vast experience in legal practice, it was expected that the nominee would contribute effectively to the operations of the JCC.

The HRC had no adverse reports against the nominee and, therefore, supported his appointment to serve as a member of the JCC.

## (iii) Mr Musa Mwenye SC

The nominee was called to the Zambian Bar in 1999 and had since served in very senior positions, including leader of the Zambian Bar as Attorney-General. In addition, the nominee had also held judicial office as a Commissioner of the Small Claims Court of the Republic of Zambia.

While in private practice, the nominee had acquired experience both nationally and internationally, having been admitted as a Solicitor of the Supreme Court of England and Wales and also having served as President of the Law Association of Zambia (LAZ). The nominee had personally advocated against corruption by appearing on various platforms to address various aspects of corruption and the rule of law. This demonstrated his commitment to fighting corruption.

In view of the above, the HRC was satisfied that the nominee possessed the requirements to serve as Chairperson of the ACC Board.

## (iv) Mrs Irene Musonda Chongo Lamba

The nominee was a legal practitioner and advocate of the superior Courts with twenty-five (25) years experience in all aspects of the law. The nominee had vast experience in administrative matters having run a successful law firm both as a sole proprietor and a partner.

The nominee had served in senior positions at the ACC namely: Deputy Director-General and Director-General (for administrative purposes). Further, she had also served as a member of the Legal and Justice Reforms Commission. The wealth of experience the nominee possessed from both public and private practice was an added advantage which would enable her effectively contribute to the development and operations of the ACC.

As a result, the HRC had no reservations about supporting the nominee's appointment to serve as a member of the ACC Board.

## (v) Dr Henry Bwanga Mbushi

The nominee was an advocate of the superior courts of Zambia. He had previously held a senior position in the Government when he served as Deputy Ambassador to Belgium. Additionally, the nominee had served as a part-time lecturer in various universities and, as a published author, had made key contributions on significant legal subjects.

A scrutiny of the nominee's background had revealed that he was part of the United Party for National Development's (UPND) legal team. This appeared contrary to paragraph 2 of the Schedule to the Anti-Corruption Act, which did not allow a person holding a position in a political party to be appointed to the Anti-Corruption Commission Board. However, HRC could not confirm whether the nominee was a member of the UPND Party. Additionally, if the nominee was to relinquish his position in the UPND, then his ratification process would have to commence *de novo*.

# (vi)**Dr O'brien Kaaba**

The nominee was a distinguished academician and consultant with diverse experience. He had been actively involved in research and consultancies in areas such as constitutional law, administrative law, governance, legal process, human rights and humanitarian law. The nominee had also served in high level positions such as *ad hoc* member of the Local Government Elections Tribunal.

Further, the nominee had acquired knowledge and skills in corruption prevention through training he had received organised by the Anti-Corruption Resource Centre and the Norwegian Embassy. The nominee's background, training and experience in human rights and corruption would be of invaluable benefit to the composition and operations of the ACC Board.

The nominee satisfied the minimum statutory requirements for appointment and, therefore, the HRC supported his appointment to serve as a member of the ACC Board.

## (vii) Mr Gilbert Andford Phiri

The nominee had since his admission to the Zambian Bar in 2007 acquired extensive expertise in legal practice spanning a period of more than fourteen (14) years. In his legal practice, the nominee had been involved in various areas of practice, including public interest litigation in criminal law, among others. The nominee was currently the Managing Partner at PNP Advocates, a law firm whose area of expertise included criminal defence and prosecution.

The nominee satisfied the statutory requirements for appointment to serve as Director-General of the ACC, and, therefore, the HRC had no objection to his appointment.

## (viii) Dr Pamela Towela Sambo

The nominee was a legal practitioner with over twenty (20) years at the Zambian Bar. She had vast experience in academia and legal research. Her career path included many roles ranging from working as in-house counsel, consultancy and lecturer including holding the position of Assistant Dean (Undergraduate) in the School of Law at the University of Zambia. In these roles, she had done extensive work in environmental law, human rights and constitutionalism.

In that regard, the nominee satisfied the criteria set out in section 5 (3) of the Human Rights Commission Act for appointment as Vice-Chairperson of the Human Rights Commission. In addition, the nominee's rich experience in matters of the law and human rights would contribute greatly in achieving the mandate of the HRC.

The HRC had neither received nor found any adverse information against the nominee in so far as human rights violations or professional misconduct were concerned. As a result, the HRC had no reservations to her appointment to serve as Vice-Chairperson of the HRC.

## (ix) Revd Canon Emmanuel Yona Chikoya

The nominee was a renowned clergyman who had served the Anglican Church in Zambia for over twenty (20) years. The nominee was currently serving as Secretary-General of the Council of Churches in Zambia. The nominee's work had not been limited to being a conventional clergyman, because he had also demonstrated leadership and keen interest in issues around social justice and governance. Additionally, he had helped marginalised groups of society in local townships, raised awareness around human trafficking and child labour and had been a voice of the people on economic empowerment matters.

Therefore, the nominee's impeccable track record, dedication to service and commitment to social justice would be valuable in providing oversight in the discharge of the HRC's mandate. The HRC had no adverse information on the nominee which could disqualify him from serving as a Commissioner of the HRC and, thus, supported his appointment.

## (ix) Mr Tom Trevor Shamakamba

The nominee was a legal practitioner with over twenty-five (25) years experience at the Zambian Bar. He had been Managing Partner at Shamakamba & Associates for about twenty-one (21) years. The nominee had previously worked as in-house counsel and lecturer of law. In addition, he had served as a member of the Council of the LAZ.

The HRC had no adverse information on the nominee and, therefore, supported his appointment to serve as a Commissioner of the HRC.

## (xi) Ms Laura-Mary Miti

The nominee was a well-known human rights advocate with extensive experience in civil society activism. The nominee's activism and passion for human rights and good governance had won her many accolades and awards among them; Southern African Human Rights Defender of the Year (Southern African Human Rights Defenders Network), 2021, Scottish Human Rights Defender Fellow, Activist of the year 2017 and Most Influential Social Media Activist of 2016.

In the recent past, the nominee had shown bravery in the fight against injustice and the protection of constitutionalism. The nominee had proven integrity and values because she spoke out even when her personal liberty was threatened. The HRC would greatly benefit from her activism skills and her passion for human rights. It was hoped that, in her role as Commissioner, the nominee would continue to play the role of being a bridge between the rights holders and duty bearers.

A search on the HRC data base did not reveal any reports of human rights violations against the nominee. With regard to the nominee's alleged advocacy for lesbian and gay rights, the HRC could not advocate for rights that were not provided for in the Constitution of Zambia. The HRC had no adverse information on the nominee and, therefore, had no objection to the nominee's appointment as Commissioner on the HRC.

# (xii) Ms Christine Chama

The nominee was a social scientist with a bias towards social work. She had experience as an advisory Board member and also served as President of the University of Zambia Development Studies Association as well as the Students Living with Disabilities representative. Further, as a person with a disability herself, the nominee would add the voice of persons with disabilities and other marginalised groups of society to the HRC. The nominee's appointment also provided a positive gender dimension to the membership of the HRC.

The HRC had no adverse information on the nominee and, therefore, had no objection to her appointment.

# THE ZAMBIA QUALIFICATIONS AUTHORITY (ZAQA)

**11**. The Chief Executive Officer submitted that ZAQA was established to develop and implement a national qualifications framework and provide measures to ensure that standards and registered qualifications were internationally comparable. She added that, in line with its mandate, ZAQA was responsible for independently validating and evaluating all qualifications for recognition in Zambia.

She further submitted that the process of validating and evaluating qualifications included the following three stages:

- (i) establishing the accreditation status or recognition of the awarding body that conferred the qualification. This stage sought to affirm that the awarding body, be it local or foreign, had the legal mandate or delegated authority from central government or from a government agency to award nationally recognised and quality assured qualifications;
- (ii) confirmation from the awarding body that the qualification was, indeed, genuinely awarded to the holder of the qualification; and
- (iii) establishing the level, on the Zambia Qualifications Framework (ZQF), at which a particular qualification should be recognised, considering set standards of competence for each level of qualification. She added that the Zambia Qualifications Framework was a single integrated system which comprised three coordinated qualifications sub-frameworks for –
  - (a) general education;
  - (b) trades and occupations; and
  - (c) higher education.

The Chief Executive Officer submitted that having considered the legal provisions relating to the nominees' appointments, ZAQA subjected the qualifications of the nominees to the

evaluation and validation process. She further informed the Committee that where the law was silent, ZAQA considered whether the nominee possessed any post-graduate qualifications. She stated that the results were as set out below.

# (i) Judge Prisca Matimba Nyambe (Rtd)

The nominee's qualifications were authentic, and were duly awarded to her by credible institutions.

## (ii) Mr Chad Himoonga Muleza

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions.

# (iii)Mr Musa Mwenye SC

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions.

# (iv)Mrs Irene Musonda Chongo Lamba

The nominee's qualifications were authentic, and were duly awarded to her by credible institutions.

## (v) Dr Henry Bwanga Mbushi

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions. However, ZAQA was awaiting confirmation on the nominee's Doctor of Philosophy in Legal Studies qualification from the Atlantic International University, Diploma in corporate law from the University of South Africa and Pearson Edexcel General Certificate of Education (GCE) from Pearson Edexcel and the GCE qualification from the Cambridge Assessment International Education. In that regard, ZAQA was unable to verify the authenticity of the certificate because certain vital information necessary for the process could only be obtained from the respective school.

## (vi)Dr O'brien Kaaba

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions. However, ZAQA was awaiting confirmation on the nominee's Bachelor of Laws qualification from the University of London. In that regard, ZAQA was unable to verify the authenticity of the certificate because certain vital information necessary for the process could only be obtained from the respective school.

## (vii) Mr Gilbert Andford Phiri

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions.

### (viii) Dr Pamela Towela Sambo

The nominee's qualifications were authentic, and were duly awarded to her by credible institutions. However, ZAQA was awaiting confirmation on the nominee's Doctor of Philosophy in Law qualification from the University of Manchester. In that regard, ZAQA was unable to verify the authenticity of the certificate because certain vital information necessary for the process could only be obtained from the respective school.

### (ix)**Revd Canon Emmanuel Yona Chikoya**

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions. However, ZAQA was awaiting confirmation on the nominee's Diploma in Religious Studies qualification from the University of Cambridge and Oxford, respectively. In that regard, ZAQA was unable to verify the authenticity of the certificate because certain vital information necessary for the process could only be obtained from the respective school.

## (x) Mr Tom Trevor Shamakamba

The nominee's qualifications were authentic, and were duly awarded to him by credible institutions

### (xi)Ms Laura Miti

The nominee's qualifications were authentic, and were duly awarded to her by credible institutions

### (xii) Ms Christine Chama

The nominee's qualifications were authentic, and were duly awarded to her by credible institutions

The Chief Executive Officer concluded her submission by stating that, apart from the qualifications which were yet to be authenticated, all the nominees held genuine qualifications and qualified for appointment to the various positions. On that basis, ZAQA supported their appointment.

## TRANSPARENCY INTERNATIONAL ZAMBIA (TIZ)

**12.** The Advocacy, Policy and Research Specialist Lead submitted that, in line with its standard procedure, TIZ conducted assessments of the nominees using the following methodology:

### 1. Legal Requirement

The Presidential appointments of the members of the Judicial Complaints Commission, the Chairperson and Members of the ACC Board, the Director-General of the ACC and the Commissioners of the Human Rights Commission were made in accordance with the Constitution of Zambia, the Anti-Corruption Act and the Human Rights Commission Act.

### 2. Security Vetting

TIZ was not a security wing with access to intelligence information, thus, its vetting was based on what was publicly available regarding the nominees' position on various issues that

bordered on national security. In that regard, TIZ's security vetting focused on any public attitude that the nominees could have adopted on matters of public security.

# 3. Independence/Objectivity test

The above methodology was, in most cases, an in-house analysis of data obtained. The focus was to establish how independent or objective the nominees would be, if ratified. Further, the work history and performance of the nominees were also considered.

# 4. **Public Integrity and Standing test**

Using public and private records, TIZ assessed whether the nominees were people of high integrity and good standing in society. This was because only a person of integrity could qualify for appointment as a member of the JCC, Chairperson and member of the ACC Board, Director-General of the ACC and a Commissioner of the HRC.

# 5. Skills Matching

TIZ carefully scrutinised the *curricula vitae* of the nominees to assess whether the nominees would perform their duties in line with the Constitution of Zambia, the Anti-Corruption Act, the Human Rights Commission Act, and the general principles of good corporate governance.

Further, the Advocacy, Policy and Research Specialist Lead submitted a brief background of the nominees and their qualifications, to ascertain whether they qualified for appointment. He submitted as set out below.

# (i) Judge Prisca Matimba Nyambe, SC (Rtd)

The nominee had adequate academic qualifications and experience as indicated in her *curriculum vitae*. She was highly qualified with over forty-three (43) years' experience. She was once Legal Counsel at the Bank of Zambia and had been a Judge of the High Court for nine (9) years. During her working life, there had not been any concerns about the nominee's integrity and independence.

TIZ had no objections to the appointment of the nominee to serve as a member of the JCC due to her high level of integrity and experience demonstrated by her depth of knowledge and skill both at the Bar and the Bench. In that regard, TIZ supported her appointment.

## (ii) Mr Chad Himoonga Muleza

The nominee had adequate academic qualifications and experience as indicated in his *curriculum vitae*. He had vast experience as an advocate having been admitted to the Bar in 1981. He had been in private practice for over forty (40) years. Further, although he had not served as a Judge, he was qualified to be one.

The nominee was closely associated with the Republican President having served as a lawyer for the United Party for national Development (UPND) party President in 2015 and 2020 when the UPND President appeared before the police for questioning.

TIZ, nonetheless, recommended the appointment of the nominee to serve as a member of the JCC provided he ceased his legal representation for and association with the Republican President.

### (iii) Mr Musa Mwenye, SC

The nominee was of proven integrity having been a legal practitioner for more than twentytwo (22) years and having served as Solicitor-General and Attorney General of the Republic of Zambia. The nominee met the minimum qualifications to serve as a member of the ACC Board and would add value to the fight against corruption. Additionally, the ACC did not have any integrity or independence concerns about him.

In that regard, TIZ had no objection to his appointment to serve as Chairperson of the ACC.

### (iv) Mrs Ireen Musonda Chongo Lamba

The nominee had been a legal practitioner for more than twenty-eight (28) years. She possessed a wealth of experience on the operations of the ACC, having previously served as Deputy Director-General and Acting Director-General for administrative convenience.

The nominee was charged with the offence of abuse of office for holding the office of Acting Director- General of the ACC while being a partner in a law firm. However, the charge was later dismissed by the Lusaka Magistrate Court on grounds that she had not been ratified as Director-General. TIZ did not have any concerns about the court case involving the nominee because it was dismissed by the courts.

The nominee met the minimum qualifications to serve as a member of the ACC Board and would add value to the fight against corruption.

### (v) **Dr Henry Bwanga Mbushi**

The nominee had been a legal practitioner for more than forty-one (41) years having been admitted to the Bar in 1980. Further, there were no concerns about his integrity or independence.

Additionally, the nominee met the minimum qualifications to serve as a member of the ACC Board and would add value to the fight against corruption.

## (vi) **Dr O'brien Kaaba**

The nominee had been a legal practitioner for more than twelve (12) years. He had lectured law at the University of Zambia (UNZA) since 2016 and had written articles on corruption.

The nominee met the minimum qualifications to serve as a member of the ACC Board and would add value to the fight against corruption. Additionally, there were no concerns about the nominee's integrity and independence. Therefore, TIZ supported his appointment.

### (vii) Mr. Gilbert Andford Phiri

The nominee had adequate academic qualifications and experience as indicated in his *curriculum vitae*. He had been a legal practitioner for more than fifteen (15) years. The nominee was associated with the President and the United Party for National Development

(UPND), having served as a lawyer for the President in the case of publication of false news in 2012 and the Treason case in 2017. The nominee had also represented the UPND Secretary-General in cases against the Electoral Commission of Zambia (ECZ), Zambia National Broadcasting Corporation (ZNBC) and the Attorney- General. In addition, the nominee was the Vice-Chairperson of the Energy Regulation Board (ERB).

TIZ had no objection to the appointment of the nominee to serve as Director-General of the ACC on the basis of his qualifications. However, TIZ recommended that the appointment be made subject to the nominee severing his legal representation of and association with the President and the UPND.

# (viii) Dr Pamela Towela Sambo

The nominee had adequate academic qualifications and experience as indicated in her *curriculum vitae*. In addition, she had been a legal practitioner for over twenty-one (21) years. Further, there were no concerns about her integrity and independence.

In that regard, the nominee met the minimum qualifications to serve as Vice-Chairperson of the HRC and would add value to the promotion, protection, and enforcement of human rights. TIZ, therefore, had no objection to her appointment.

# (ix) Revd Canon Emmanuel Yona Chikoya

The nominee had adequate academic qualifications and experience as indicated in his *curriculum vitae*. He also met the minimum requirements to serve as a Commissioner of the HRC. He was a notable religious figure and defender of human rights and freedoms. Further, TIZ did not have any concerns about his integrity and independence.

He would, therefore, contribute to the promotion, protection, and enforcement of human rights and TIZ had no objection to his appointment.

## (x) Mr Tom Trevor Shamakamba

The nominee had adequate academic qualifications and experience as indicated in his *curriculum vitae*. He had been a legal practitioner for over twenty-six (26) years having been admitted to the Bar in 1995. The nominee, therefore, met the minimum qualifications to serve as a Commissioner of the HRC and would add value to the promotion, protection, and enforcement of human rights. Additionally, the nominee did not have any integrity and independence concerns.

The nominee had a seemingly close association with the UPND having represented twentyseven (27) UPND Chingola officials in a case of unlawful assembly.

TIZ had no objection to the nominee's appointment, but recommended that he ceased his association with the UPND party in order to exhibit his independence and objectivity.

## (xi) Ms. Laura-Mary Miti

The nominee had adequate academic qualifications and experience as indicated in her *curriculum vitae*. She had demonstrated vast experience of over twenty-five (25) years in civil society and was one of the notable human rights activists in Zambia.

The nominee met the minimum qualifications to serve as a Commissioner of the HRC and would add value to the promotion, protection, and enforcement of human rights. In addition,

she had no integrity and independency concerns. Therefore, TIZ had no objection to her appointment.

### (xii) Ms Christine Chama

The nominee possessed adequate academic qualifications and experience as indicated in her *curriculum vitae*. She had also demonstrated experience and skill in sociology. Further, TIZ did not have any concerns about her integrity and independence.

Being a person living with a disability herself, the nominee had been a notable disability advocate. She would, therefore, champion the rights of differently abled citizens. Additionally, the nominee met the minimum qualifications to serve as a Commissioner of the HRC and would add value to the promotion, protection, and enforcement of human rights. Therefore, TIZ had no objection to her appointment.

# SOUTHERN AFRICAN CENTRE FOR THE CONSTRUCTIVE RESOLUTION OF DISPUTES (SACCORD)

**13**. The Executive-Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. He noted that the institutions, to which the nominees were being appointed to, would be more effective as a result of the nominees' gender balance as well as their diverse professions and experiences. He further submitted on each of the nominees as set out below.

## (i) Judge Prisca Matimba Nyambe, SC (Rtd)

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. He noted that the nominee had a clear track record where work was concerned. Further, being female, her appointment would enhance the ideals of gender equality. A background check had revealed that the nominee was a person of integrity.

In that regard, SACCORD had no objection to the nominee's appointment to serve as a member of the JCC.

### (ii) Mr Chad Himoonga Muleza

The nominee had the requisite academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as a member of the JCC.

### (iii) Mr Musa Mwenya, SC

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as Chairperson of the ACC Board.

# (iv) Mrs Ireen Musonda Chongo Lamba

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, she was a Zambian national with a clear track record where work was concerned. In addition, her appointment was good for gender equality. Further, a background check revealed that the nominee was a person of integrity.

In that regard, SACCORD had no objection to the nominee's appointment to serve as a member of the ACC Board.

## (v) **Dr Henry Bwanga Mbushi**

The nominee had the necessary academic qualifications and satisfied the legal requirements for appointment to the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as a member of the ACC Board.

## (vi) **Dr O'brien Kaaba**

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

In that regard, SACCORD had no objection to the nominee's appointment to serve as a member of the ACC Board.

## (vii) Mr Gilbert Andford Phiri

The nominee had the requisite academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as Director-General of the ACC.

## (viii) Dr Pamela Towela Sambo

The nominee had the requisite academic qualifications and satisfied the legal requirements for appointment as Vice-Chairperson of the HRC. Further, she was a Zambian national with a clear track record where work was concerned. In addition, her appointment was good for gender equality. Further, a background check revealed that the nominee was a person of integrity.

In that regard, SACCORD had no objection to the nominee's appointment to serve as the Vice-Chairperson of the HRC Board.

## (ix) **Revd Canon Emmanuel Yona Chikoya**

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as a member of the HRC Board.

## (x) Mr Tom Trevor Shamakamba

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, he was a Zambian national with a clear track record where work was concerned. A background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as a member of the HRC Board.

# (xi) Ms Laura-Mary Miti

The nominee had the necessary academic qualifications and satisfied the legal requirements for the position. Further, she was a Zambian national with a clear track record where work was concerned. In addition, her appointment was good for gender equality. Further, a background check revealed that the nominee was a person of integrity.

In that regard, SACCORD had no objection to the nominee's appointment to serve as a member of the HRC Board.

## (xii) Ms Christine Chama

The nominee had the requisite academic qualifications and satisfied the legal requirements for the position. Further, she was a Zambian national with a clear track record where work was concerned. In addition, her appointment was good for gender equality. Further, a background check revealed that the nominee was a person of integrity.

Therefore, SACCORD had no objection to the nominee's appointment to serve as a member of the HRC Board.

## FOUNDATION FOR DEMOCRATIC PROCESS (FODEP)

14. The Executive Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. He submitted that the members and commissioners of the three (3) institutions played a critical oversight role in enhancing the reputation, efficiency, independence, effectiveness, client satisfaction and confidence in the three (3) bodies and governance at large. He added that the nominees offered a varied range of professional backgrounds and experience, which was commendable. Further, the nominees appeared to be well-balanced in terms of gender. He then submitted on each nominee as set out below.

## (i) Judge Prisca Matimba Nyambe, SC (Rtd)

The nominee possessed extensive expertise from her work in Africa and around the world, notably with the United Nations. She had also worked for many courts and tribunals, particularly, on matters involving genocide and humanitarian issues, where she had shown courage and boldness in her rulings.

The nominee exhibited independence, credibility and integrity and was, therefore, well placed to serve on the JCC Board. In that regard, FODEP endorsed the appointment of the nominee to serve on the JCC Board.

### (ii) Mr Chad Himoonga Muleza

The nominee was well qualified and had extensive experience in the judicial and legal profession, as evidenced by his *curriculum vitae*. However, FODEP expressed a reservation about the nominee because of his apparent connection to the Minister of Home Affairs and Internal Security, given that he had worked (or was currently working) for Muleza Mwiimbu and Company, a firm with which the Minister of Home Affairs and Internal Security was involved.

While the nominee was suitably qualified to serve on the JCC, due to his apparent connection to the Minister of Home Affairs, his appointment to such a critical body, which should engender a public perception of being fully independent of the whims of any of the other three arms of government (especially the Executive), would be questionable. Additionally, this would render the JCC to be potentially disposed to serve the Executive's interests in cases where government had a perceived interest.

### (iii)Mr Musa Mwenye, SC

The nominee was a well-qualified and experienced legal practitioner who was one of the few people to request a lifestyle audit for public officials. This had demonstrated his openness and commitment to fighting corruption. Further, his passion to fight corruption had been fairly strong throughout his career.

Therefore, FODEP was of the considered view that the nominee would be able to significantly contribute to the ACC. As a result, FODEP had no reservation on the nominee's appointment to serve as Chairperson of the ACC Board.

### (iv)Mrs Ireen Musonda Chongo Lamba

The nominee had a lot of expertise and was well-versed in dealing with corruption matters. She had served at the ACC in several capacities, including as Deputy Director-General. In that regard, FODEP was of the considered view that the nominee was qualified to serve on the Board.

## (v) Dr Henry Bwanga Mbushi

The nominee was a well-educated and well-travelled man with a wealth of expertise. However, FODEP had reservations about the nominee's past and current ties to the ruling UPND party, particularly his role as a member of the UPND Legal Committee (2014-2021). Further, the nominee was a member of the legal team that represented the party's president when in opposition. Therefore, his nomination could be interpreted as a reward and partisanship. This could affect the public's image of the independence of the ACC.

The ACC was a delicate institution that required people who would carry out their responsibilities impartially. In that regard, FODEP recommended that the nominee be reserved for appointment to another entity where impartiality would be less critical.

### (vi) **Dr O'Brien Kaaba**

The nominee was a well accomplished academician and researcher who had specialised in a variety of democratic governance concerns, mostly from a legal perspective. In that regard, FODEP was satisfied that the nominee's extensive expertise in the legal, academic, and other fields where he had worked would add significant value to the Commission.

Therefore, FODEP supported the nominee's appointment to serve as member of the ACC Board.

# (vii) Mr Gilbert Andford Phiri

The nominee had extensive expertise and deserved to serve in the position, as evidenced by his *curriculum vitae*, which indicated that he was well-versed in corruption matters. However, the nominee was one of the lawyers who had defended the UPND party president, as he was then, in the treason trial. In view of the above, FODEP expressed reservations about the nominee's appointment, stating that it could be interpreted as a "reward" for his service and that it could impact his independence as ACC Director-General. The nominee had also been the subject of complaints before the Law Association of Zambia.

# (viii) Dr Pamela Towela Sambo

The nominee possessed exceptional qualifications and expertise and, therefore, qualified to serve on the HRC Board. The HRC would benefit from her extensive experience gained from her over seventeen (17) years of human rights advocacy and teaching, as well as her distinguished academic career.

In that regard, FODEP supported the nominee's appointment without reservations.

# (ix) Revd Canon Emmanuel Yona Chikoya

The nominee had served the church in a variety of capacities. Additionally, he was an active participant in the governance sector, and was a member of the Christian Churches Monitoring Group (CCMG). While the nominee's skills and experiences were not directly related to human rights, his background in the church and governance activism gave him a solid foundation and the capacity to adapt and contribute to the objectives of the HRC.

Therefore, FODEP was not opposed to the appointment of the nominee to serve as a Commissioner of the HRC.

## (x) Mr Tom Trevor Shamakamba

The nominee had experience in legal practice spanning over twenty-five (25) years and was an academician. FODEP did not find any additional information on the nominee from other sources, and, therefore, relied on the summarised *curriculum vitae*, which was presented to it.

In that regard, FODEP lacked sufficient information on which to base its support or opposition to the nominee's appointment.

# (xi) Ms Laura-Mary Miti

The nominee was widely recognised as a human rights advocate who had openly spoken out against social injustices on numerous occasions and had stood up to government and corrupt practices. Her civic activism skills would be beneficial to the HRC. However, FODEP hoped

that the nominee's appointment would not serve to quieten or dampen her enthusiasm, causing her to be less vocal than she had been in the NGO sector.

Nonetheless, FODEP had no objections to the nominee's appointment as a Commissioner of the HRC.

## (xii) Ms Christine Chama

The nominee's qualifications and experience were not explicitly related to human rights. However, she possessed a university degree, which was a minimum requirement for serving as a Commissioner. Further, the nominee's appointment would ensure that the concerns and interests of marginalised persons with disabilities were considered.

In that regard, FODEP supported the appointment of the nominee to serve as a Commissioner of the HRC Board.

# JUDICIAL SERVICE COMMISSION (JSC)

**15.** The Chairperson submitted on the personal, academic and professional background of the nominee for appointment as Vice-Chairperson of the JCC as contained in her *curriculum vitae*.

The nominee possessed an impeccable record, with vast experience in the legal fraternity. She had served in various senior positions within Zambia and abroad. In addition, the nominee's service to the Judiciary of Zambia was exemplary and it was for that reason that she had headed the Commercial List as Judge-in-Charge.

The nominee was a very dedicated person who commanded dignity and respect from both the Bar and the Bench. In that regard, the nominee's positive attributes outweighed her negatives.

In conclusion, the Chairperson stated that the nominee was suitably qualified and that the JSC had no reservation with regard to her appointment.

# LAW ASSOCIATION OF ZAMBIA (LAZ)

**16.** The Vice-President of LAZ stated that the Council of LAZ, with the help of State Counsel, had deliberated on the suitability of the nominees for appointment.

The Vice-President emphasised the need for the nominees to be reminded that despite their perceived political inclinations, it was important for them to remain neutral as they served the country. He stated that it was in the public domain that some of the nominees had represented the ruling party in some court matters, and in that regard, it was of utmost importance that they maintained neutrality in the discharge of their duties. He explained that in as much as political affiliation was not forbidden, it was important that once appointed to public office, people discharged their functions without segregation. In that regard, the Chairperson submitted on the personal, academic and professional background of the nominees as contained in their *curricula vitae*.

He concluded his submission by informing the Committee that LAZ was confident that the nominees would perform their various tasks diligently. He added that LAZ had no active

cases against any of the nominees and, therefore, supported their appointment without reservation.

# JUDICIAL COMPLAINTS COMMISSION (JCC)

**17.** A Member of the JCC informed the Committee that the institution, in line with its mandate would submit on the suitability or otherwise of Judge Prisca Matimba Nyambe, SC, (Rtd). In that regard the member submitted on the personal, educational and professional background of the nominee as stated in her *curriculum vitae*.

The nominee had served in various institutions where she had a proven record of undeniable work ethics. He added that the nominee's hard work and commitment to service delivery accorded her an opportunity to work both locally and internationally. Further, the nominee served diligently as High Court Judge, where she meticulously delivered all her judgments.

Additionally, the nominee would not be influenced by the Appointing Authority in her work, but would be impartial once appointed as a member of the institution. He added that the JCC was confident that the nominee's vast experience was an important attribute, which would add value to the operations of the JCC.

The Member of the JCC concluded by submitting that the JCC had not received any complaints against the nominee and, therefore, had no reservations to her appointment to serve as a member of the JCC.

### SUBMISSIONS BY THE NOMINEES

## (i) Judge Prisca Matimba Nyambe (Rtd)

**18**. The nominee informed the Committee about her personal, academic and professional background as contained in *her curriculum vitae*.

She informed the Committee that she had served in different portfolios, locally, regionally and internationally. In that regard, she had acquired experience that would aid her in carrying out the duties of a member of the JCC. The nominee explained that she started her career as a magistrate in Kabwe where she supervised junior magistrates and that her supervisory role extended to Mumbwa, Serenje and Mkushi, among others.

The nominee submitted that the current appointment was not her first Presidential appointment as she was once appointed as a Judge of the High Court for Zambia and had discharged her duties with impartiality. She added that the cumulative number of years she had worked for the Zambian judiciary amounted to ten (10). In that regard, she was exposed to the challenges which the Zambian judicial system was faced with and, if ratified, would play an effective role in ensuring that some of those challenges were addressed.

## (ii) Mr Chad Himoonga Muleza

**19**. The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*. He further submitted on his vast experience as a legal practitioner mostly in the private sector.

The nominee submitted that he was aware that some of the complaints brought to the JCC could be mitigated by conducting extensive training on ethics and judicial conduct for those appointed before they take office. He further, submitted that the current *status quo* where adjudicators were just appointed and left to learn the work on the job needed to end. In that vein, he would recommend to the JSC, which was mandated to help the President with appointments in the Judiciary, to conduct such trainings.

The nominee also submitted that he enjoyed a cordial relationship with the Appointing Authority and the United Party for National Development (UPND) party. However, he submitted that his association with the Republican President and the ruling party was mostly professional. He assured the Committee that he would discharge his duties with impartiality.

## (iii) Mr Musa Mwenye, SC

**20**. The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

The nominee submitted that he had twenty-two (22) years of experience as a legal practitioner and that he was a member of the Inner Bar. He added that he had served the nation in several roles, including that of Solicitor-General and later Attorney-General. Further, the nominee submitted that when he served the Government in various portfolios, he had availed himself to be audited because he believed that promoted transparency and accountability.

The nominee informed the Committee that he had provided counsel on various issues of national interest with empirical evidence. In that regard, he had no personal issues against any former or current leaders. He explained that difference in opinion would always arise, but matters of corruption were best handled with evidence and not driven by personal agendas as was perceived by the public. He submitted that some of the reforms he would introduce at the ACC, if ratified, would be to ensure that extensive changes were undertaken in order to build an institution that was not politically biased. In view of this, he would strive to ensure that the work culture at the ACC was changed to enable the institution dispose of cases expeditiously because fighting corruption was an economic strategy. The nominee emphasised that the fight against corruption was a huge task and that prosecution of matters required sufficient time.

# (i) Mrs Ireen Musonda Chongo Lamba

**21**. The nominee informed the Committee about her personal, academic and professional background as contained in her *curriculum vitae*.

The nominee submitted that having a legal background gave her an advantage serving on the ACC Board. She added that she had served as Deputy Director-General of the ACC for two (2) consecutive contracts of three (3) years each. She had later served as Director-General for administrative purpose. She further stated that she had had an opportunity to attend meetings with members of the United Nations Convention Against Corruption, the Southern African Development Community Protocol against Corruption and the African Union Advisory Board on Corruption. She explained that that experience would greatly assist her in providing policy direction to the Commission. She added that, if ratified, her role at the ACC would not be operational, but advisory through the Director-General.

She further informed the Committee that while serving as Acting Director-General of the ACC, she was arrested and charged with three (3) counts for not disclosing that she was a

partner in a law firm. The first was breach of trust affecting the public contrary to section 123 of the Penal Code, Cap. 87 of the Laws of Zambia. The second was abuse of authority of office contrary to section 21(10(a) of the Anti-Corruption Act. The third was disobedience of statutory duty contrary to section 126 of the Penal Code. The charges brought under the Penal Code were dismissed while she was acquitted of the one brought under the Anti-Corruption Act.

Concerning the fight against corruption in the Civil Service, she submitted that she would ensure that directives were made to various heads of institutions or ministries to ensure that disciplinary action, including prosecution, was taken against civil servants found to have committed corrupt practices.

The nominee submitted that she wanted to leave a legacy of a highly motivated ACC that would fight corruption without fear or favour.

# (ii) Dr Henry Bwanga Mbushi

**22.** The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*. He added that from the qualifications that he submitted, it should be noted that his GCE qualifications were made up of *three* (3) different certificates and that most of his certificates could not be verified by the Zambia Qualifications Authority due to time constraints as the verification process required more time.

The nominee submitted that his nomination to the ACC was not his first Presidential appointment as he had been appointed as Deputy Ambassador to Belgium where he served until he was recalled.

The nominee also submitted that he was aware that one of the challenges facing the ACC was that of delayed disposal of cases. He explained that he would strive to ensure that the ACC and Office of the Director of Public Prosecution worked closely to ensure that cases were disposed of expeditiously. He explained that there was a need for political will to allow investigative wings to operate autonomously.

The nominee informed the Committee that he enjoyed a cordial relationship with the Appointing Authority and the United Party for National Development (UPND). However, he submitted that his association with the Republican President and the ruling party was mostly professional. He assured the Committee that he would discharge his duties with impartiality. In that regard, he explained that if he was coerced to do something by the Appointing Authority, he would in all circumstances, stand by his decision and principles. He submitted that if the coercion persisted, he would have no alternative but to resign.

## (iii) **Dr O'brien Kaaba**

**23.** The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

The nominee informed the Committee of his vast experience as an academician and that he had worked mostly for international organisations. He submitted that he was currently lecturing at the University of Zambia (UNZA) in the School of Law.

The nominee submitted that he would use his skills as a researcher to conduct a forensic audit of the problems that were perceived to be facing the ACC. He added that the evidence based

approach would be applied to foster change needed at the ACC. He explained that one of the complaints that the public had against the ACC was that it seemed to operate under the direction of the Appointing Authority or the government of the day. The nominee submitted that his work at the ACC would be centred on integrity and impartiality. He added that he could not be influenced by the Appointing Authority evidenced by his resignation from the committee that was tasked to consider the Constitution of Zambia (Amendment) Bill No 10 of 2019.

### (iv)**Mr Gilbert Andford Phiri**

**24.** The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

The nominee submitted that he started his career as a teacher after obtaining his Bachelor of Education. He later changed careers by obtaining a Bachelor of Laws degree from the University of Zambia. He added that currently, he was the Managing Partner at PNP Advocates after having worked at Messrs Muleza Mwiimbu and Company and the National Legal Aid Clinic for Women, among others. He informed the Committee that during his practice, he had the opportunity to represent leaders both in the current and past government.

He informed the Committee that he also served as Vice-Chairperson of the Energy Regulation Board (ERB). He added that he decided to resign from the ERB Board and from participating in any court process when he was informed of his appointment to serve as Director-General of the ACC. He explained that his decision to resign was to ensure that he was not conflicted.

The nominee submitted that he was a highly motivated person with credible credentials. He added that he was a principled person who pursued what was right and could not easily be persuaded. In that regard, he informed the Committee that, if ratified, he was going to improve the image of the ACC through its operations. The nominee stated that he would ensure that the ACC operated independently and with professionalism. He pointed out that, if ratified, the ACC would act on any misconduct or lack of integrity in the three (3) arms of government. In that regard, he submitted that he would ensure that past and present cases were investigated and concluded logically.

### (viii) Dr Pamela Towela Sambo

**25.** The nominee submitted to the Committee about her personal, academic and professional background as stipulated in her *curriculum vitae*.

She informed the Committee that she had a passion for human rights and, thus, had interacted with human rights issues in various aspects of the law. As an environmental law specialist, she had an opportunity to interact with human rights issues that bordered on environmental law. She added that she had experience in legal research, including in environmental, human rights and constitutional law.

The nominee explained that, as a legal practitioner, she had a duty to uphold the Constitution. She submitted that everyone was bound by the Constitution in the nation, including the Appointing Authority. In that regard, her first allegiance was to the Constitution and the Zambian people. She added that as a principled person, she would not entertain political interference in the course of executing her duties. The nominee pointed out that, as a professional, she was expected to provide guidance to the Appointing Authority and where that failed, she would resign in order to maintain her integrity.

# (ix) Revd Canon Emmanuel Yona Chikoya

**26.** The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

The nominee submitted that he had been serving as an ordained Anglican priest for over twenty (20) years. He added that he had served in various parishes with passion and had ensured that most of the members of the communities he had served in received the teachings of the Anglican Church. He explained that he was an agent of change in society by speaking on behalf of the voiceless on issues of human rights and corporate governance. He informed the Committee that his work extended beyond his priestly duties because he served on several boards which had exposed him to issues of governance. The nominee submitted that it was the same passion that had motivated him to serve in various government institutions. This showed that the church could be involved in issues of governance, human rights, and general reform in the Zambian community.

The nominee informed the Committee that, if ratified, he would advocate for the HRC's operations to be strengthened to enable it take action rather than end at making recommendations. In addition, he would advocate for an increase in the Commission's funding in order for it to increase its presence around the country. This would, consequently, result in an improvement in access to the HRC.

## (x) Mr Tom Trevor Shamakamba

**27.** The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*. He added that he was currently managing his own law firm in Ndola and was engaged in farming as well as other agricultural related businesses.

The nominee submitted that his main priority, if ratified, would be to advocate for the rights of prisoners. He stated that the non-implementation of the death penalty and the sentencing of offenders to prison for non-capital offences had contributed greatly to the congestion in prisons. He noted that there was a need to review the principles of sentencing to prescribe fines or community service in order to decongest the prisons. He added that, regardless of the offence, persons who had reformed deserved a second chance and needed to be set free or pardoned.

### (xi) Ms Laura Mary Miti

**28.** The nominee informed the Committee about her personal, academic and professional background as contained in her *curriculum vitae*.

The nominee submitted that as a human rights activist, issues of human rights had been central to her work. She added that she had received appropriate training in matters of human rights. In that regard, if ratified, she would ensure that the HRC was in the forefront of sensitising and safeguarding human rights. This would ensure that the general citizenry understood their rights as enshrined in the Constitution. She added that with the intended Constitutional reforms, the HRC would ensure that issues of socio-economic and civil and political rights were included and understood by the citizenry.

With regard to her perceived advocacy for gay rights, the nominee submitted that she was not advocating for the statute books to be amended in order to incorporate such rights. She explained that laws were mostly reflective of a people's culture and the country was not

ready to pass legislation to incorporate gay rights. She added that if the country did that, there would be a disconnect between the people's culture and the legislation, which would result in the legislation existing only on paper.

The nominee informed the Committee that the Constitution was silent on the matter. She, however, noted that other subordinate laws such as the Penal Code criminalised acts between people of the same sex. She explained that currently, the law prohibited the act and not the issue of one's sexual orientation. She submitted that her concern was that the arrests taking place resulted in the abrogation of people's right to privacy, which was protected by the Bill of Rights contained in the Constitution.

The nominee also submitted that the current laws needed to be reviewed in order to decriminalise minor offences. She said this was because not all offences required custodial sentences. She added that other forms of punishment could include community service, fines or rehabilitation. She further stated that it was the role of the HRC to ensure that the wheels of justice moved faster and were enjoyed by all, regardless of their status.

## (xi) Ms Christine Chama

**29.** The nominee informed the Committee about her personal, academic and professional background as contained in her *curriculum vitae*. She added that she was a gazetted probation officer and a dedicated advocate for the rights of persons with disabilities being a differently abled person herself.

The nominee submitted that her main priority, if ratified, would be to advocate for the rights of persons with disabilities. She added that there was need to reduce the gap that existed between the abled and the differently abled. She informed the Committee that while there were policies and documentation advocating for inclusion, there was no deliberate implementation, which needed to be reviewed.

The nominee also submitted that the rights of the differently abled needed to be recognised and protected in the judicial system and institutions responsible for arrests. She added that it was difficult for the rights of the differently abled to be considered when there were no deliberate policies to accommodate the differently abled from the point of arrest through to the point of judgement.

## SUBMISSION BY THE APPOINTING AUTHORITY

**30.** The Minister of Justice informed the Committee that he took cognisance of the legal framework relating to the nominees' appointment to the various institutions. In that regard, he submitted on each nominee as set out below.

### (i) Judge Prisca Matimba Nyambe (Rtd)

The nominee was born on 31<sup>st</sup> December, 1951.She held a Bachelor of Laws Degree from the University of Zambia and a Legal Practitioners Qualifying Postgraduate Certificate from the Zambia Institute of Advanced Legal Education. During her fortyfour (48) year long legal career, the nominee served as a Resident Magistrate in Kabwe from 1978 to 1980. From 1980 to 1984, the nominee served as a Senior Magistrate in Harare and Gwelo in Zimbabwe. In 1984 to 1992 the nominee served as Legal Counsel for the Central Bank of Zambia. Further, the nominee served as Senior Legal Officer in the Chief Court Management Section of the International Criminal Tribunal for Rwanda (ICTR) from 1996 to 2000. From 2002 to 2006, she served as General Counsel to the International Criminal Tribunal.

In 2002, the nominee was elected as Judge *ad litem* of the International Criminal Tribunal for the former Yugoslavia (ICTY). From 2006 to 2015, she served as a Judge of the High Court of the Republic of Zambia. Further, in 2011, the nominee was elected as Judge of the International Resident Mechanism for Criminal Tribunals (IRMCCT).

Additionally, the nominee undertook special assignments which included an undertaking as a Human Rights Expert and International Observer under the International Commission of Jurists and the coordination of the United Nations Observer Mission in Malawi, among others.

Over the years, the nominee organised and attended several conferences, workshops and seminars such as the Judges' Symposium by the Zambia Law Development Commission dubbed "*Re-thinking Zambia's Criminal Justice System*". She also participated in the African Dialogue on Promoting Justice and Reconciliation in African Challenges for Human Rights and Development organised by the Office of the High Commission for Human Rights in Arusha, Tanzania.

Based on her experience while serving in the Judiciary, the nominee was aware of the challenges that judges were faced with. In that regard, it was expected that she would be impartial and independent in the course of her duties.

The nominee was highly qualified, experienced and suitable for appointment as a Member of the JCC and the Government fully supported her appointment.

### (ii) Mr Chad Himoonga Muleza

The nominee was born on 12<sup>th</sup> August, 1956. He held a Bachelor of Laws Degree from the University of Zambia and was admitted to the Zambian Bar in 1981. During his forty-one (41) year legal career, the nominee served as legal counsel at the National Agricultural Marketing Board in 1982 and later worked for the Development Bank of Zambia. In 1993, the nominee opened a law firm, Muleza and Company.

In 2012, the nominee merged his law firm with Mwiimbu and Company to form Muleza Mwiimbu and Company where he became the Managing Partner, a position he holds to date. In the course of his professional career, the nominee managed the firm with an expanded scope of work, which included providing a comprehensive range of legal services and solutions for domestic and international clients.

In that regard, the nominee was highly qualified, experienced and suitable for appointment as a Member of the JCC and the Government fully supported his appointment.

### (iii) Mr Musa Mwenye SC

The nominee was born on 25<sup>th</sup> March, 1975. He held a Bachelor of Laws Degree from the University of Zambia and was admitted to the Zambian Bar in 1999. Additionally, the nominee was a Solicitor of the Supreme Court of England and Wales.

The nominee began his twenty-three (23) year legal career as a legal practitioner with Sharpe & Howard Legal Practitioners, where he worked from 2001 to 2002. In 2002, he purchased Kajimanga and Company Advocates which later merged with Sharpe & Howard Legal Practitioners to create Sharpe, Howard and Mwenye Legal Practitioners.

In 2011, the nominee was appointed Solicitor-General of the Republic of Zambia and in 2015 he Attorney-General. As Attorney-General, the nominee was an ex-officio member of the Cabinet and leader of the Zambian Bar. The nominee is currently serving as a Senior Partner at Mwenye & Mwitwa Advocates.

The nominee was, among other several appointments, appointed by the Secretary General of the Commonwealth to be part of the Commonwealth election observer mission to the Ghanaian elections held in 2016 and 2019. Additionally, the nominee had held judicial office as a Commissioner of the Small Claims Court of the Republic of Zambia and was currently a member of the PACT Global Board of Directors, an international non-governmental organisation based in Washington DC, USA.

The nominee had also served in various capacities, including Honorary Secretary, Council Member and Chairperson of the Law Association of Zambia from 2007 to 2008. He had previously served as a member of the Statutory Audit Committees of three ministries of the Government of the Republic of Zambia, namely, Ministry of Transport and Communications, Ministry of Information and Broadcasting Services and the Ministry of Sport, Youth and Child Development.

In that regard, the nominee was highly qualified, experienced and suitable for appointment as Chairperson of the ACC and the Government fully supported his appointment.

### (iv) Mrs Irene Musonda Chongo Lamba

The nominee was born on 11<sup>th</sup> February, 1971. She held a Bachelor of Laws Degree from the University of Zambia and was admitted to the Bar on 30<sup>th</sup> December, 1993. During her twenty-nine (29) year long legal career, the nominee had worked as a Learner Legal Practitioner at Messrs Richard Ngenda and Company in 1993. From 1994 to 2011, the nominee worked in numerous law firms, among others, Chongo, Manda and Associates were she became a partner in 2009.

In 2012, the nominee was appointed Deputy Director of the ACC. From 2016 to 2018, the nominee served as Acting Director-General of the ACC for administrative purposes. The nominee, therefore, had extensive administration and prosecution acumen gained from working as Deputy Director and Acting Director-General of the ACC, as well as from participating in high-level meetings and conferences both

locally and internationally on behalf of the Commission and the Republic of Zambia. The nominee was a person of integrity who had served the ACC diligently.

Having served the ACC in various portfolios, the nominee knew the challenges the ACC faced and, therefore, would provide insight to the Board on the operations of the ACC.

From 2018 to date, the nominee was a partner in Chongo, Manda and Associates.

During her tenure at the ACC, some charges had been instituted against her, but she was not convicted. Therefore, there was no conviction against the nominee that would disqualify her from serving on the ACC Board.

The nominee possessed vast experience and skills obtained from both the private and public sectors. In addition, she had proven experience in all aspects of the law, including civil and criminal (defence) matters, corporate law, matrimonial disputes, intestate succession, probate, conveyance, local and international agreements, defamation matters, employment and labour issues and real estate matters. Further, she had vast experience in administration having run a successful law firm both as a sole proprietor and a partner.

The nominee was goal oriented, disciplined and committed to achieving desired results with minimum or no supervision. She was also sociable, a team worker and possessed the ability to adapt and adjust to a changing work environment.

The nominee was highly qualified, experienced and suitable for appointment as a Commissioner of the ACC and that Government fully supported her appointment.

### (v) **Dr Henry Bwanga Mbushi**

The nominee obtained a Bachelor of laws Degree from the University of Zambia in 1979 and was admitted to the bar in 1980. He also held a Diploma in Corporate Law obtained from UNISA and a Doctorate degree (PhD) in Public International Law obtained from Atlantic International University in the United States of America. He also possessed a number of post-graduate certificates obtained locally and from abroad, including a Masters of Laws obtained from Kent University, in Belgium.

During his forty-one (41) year long legal career, the nominee mainly worked in private practice until 2009 when he was appointed to serve as Deputy Ambassador to Belgium, a position he held until 2012. The nominee also served as a part-time lecturer at various universities, including the University of Lusaka, the University of Africa and the Kenneth Kaunda Metropolitan University.

Further, the nominee was involved in community work and represented Zambia as a Board Member at the Pan-African Mineral Development Corporation in South Africa. He was also a member of the Cancer Board at the University Teaching Hospital as well as the Museum Board of Zambia. Additionally, the nominee was a member of the Zambian Constitutional Review Commission chaired by Mr W Mung'omba.

The nominee was a mature and seasoned legal practitioner whose wealth of experience would be beneficial to the ACC Board. The nominee was, therefore,

qualified, experienced and suitable for appointment as a member of the ACC Board and the Government fully supported his appointment.

### (vi) **Dr O'brien Kaaba**

The nominee held a Bachelor of laws Degree obtained from the University of London. The nominee also possessed various postgraduate qualifications, including a Master of Laws (LLM) degree from the University of Zambia and a Doctorate degree (LLD) obtained from UNISA. He also held a Diploma in Philosophy obtained from Saint Augustine Catholic Philosophical College in Kabwe.

During his sixteen (16) year legal career, the nominee held various positions in the legal profession in Zambia. He had, among others, served as Legal Advisory Services Coordinator for Women in Law and Development in Africa (WiLDAF) from 2006 to 2008 before he joined Plan International as Child Protection Coordinator in 2008. Thereafter, the nominee served as Legal Assistant and Program Manager for Women's Justice and Empowerment Initiative (WJEI) in the Department of Justice at the US embassy in Lusaka. He also served as Political Specialist, Department of State at the American Embassy in Lusaka, from 2010 to 2012. Further, the nominee served as Advisor-Human Rights and Rule of Law to the German Development Cooperation (GIZ) Zambia. In addition, the nominee served as Program Manager – Elections between 2015 and 2016 at the National Democratic Institute for International Affairs (NDI) and from 2017 to date, he served as Associate Editor and later Managing Editor of the SAIPAR Case Review Journal.

The nominee, who was, currently, a lecturer at the University of Zambia, was an accomplished scholar who had extensively written peer reviewed articles on diverse subjects, but mainly focused on constitutionalism and human rights. Given his expertise, the nominee would immensely enhance the effectiveness of the ACC and thereby assist the institution perform its mandate in line with the Constitution and the expectations of the people of Zambia.

The nominee was a man of integrity with no record of misbehaviour. He would, therefore, serve the ACC with dignity and impartiality. In that regard, the nominee was eminently qualified, experienced and suitable for the appointment to serve as a member of the ACC Board, and, therefore, Government fully supported his appointment.

## (vii) Mr Gilbert Andford Phiri

The nominee was born on 15<sup>th</sup> December, 1970. He held Bachelor of Arts with Education degree (BAEd) and a Bachelor of laws degree (LLB) obtained from the University of Zambia. He also possessed postgraduate qualifications which included a Legal Practitioners Qualifying Examination Certificate obtained from ZIALE in 2007 and a Master of Laws Degree (LLM) in Sports Law and Practice, Intellectual Property Law, Broadcasting and New Media from De Montfort University, Leicester in the United Kingdom.

During his seventeen (17) year illustrious legal career, the nominee served in various positions both in the private and public sector. He served as a learner legal practitioner at Messrs Kajimanga and Company and also at Messrs sharpe, Howard

and Mwenye Legal Practitioners from 2005 to 2007. The nominee served as Senior Legal Officer at the Law Association of Zambia and National Legal Aid Clinic for Women from 2008 to 2010. Further, he also he served as an Advocate at Messrs Muleza Mwiimbu and Company from 2010 to 2013 and from 2013 to date, the nominee was serving as the Managing Partner of PNP Advocates.

The nominee handled high profile criminal and civil cases most of which were reported in the Zambia Law Reports. In his practise of the law, the nominee was known for his aggression in pursuing the correct legal position in all cases. He had an impeccable ability to balance the interest of the law and ensure that the court was properly informed on matters that involved his clients. The nominee had demonstrated the desire to strictly adhere to and follow what the law provided even where such adherence was not in favour of his client. It was, among others, due to such attributes that the nominee was considered to serve as Director-General of the ACC.

The nominee was, therefore, highly qualified, experienced and suitable for appointment as the Director-General of the ACC and the Government fully supported his appointment.

### (viii) Dr Pamela Towela Sambo

The nominee held a Bachelor of Laws degree obtained from the University of Zambia in 1998 and was admitted to the Bar in 1999. The nominee also possessed postgraduate qualifications that included a Master of Laws (LLM) degree in Environmental Law from the University of KwaZulu-Natal, Pietermaritzburg, in South Africa and a Doctorate (PhD) degree in Environmental Law obtained from the University of Manchester in the United Kingdom.

During her illustrious twenty-four (24) year long legal career, the nominee served in various positions in the legal profession. She served as learner legal practitioner and associate legal practitioner at Ellis & Company from 1998 to 2000 and later joined Mvunga Associates as associate legal practitioner until 2002. Later in 2002, she worked at the University of KwaZulu-Natal, Pietermaritzburg, South Africa in the School of Law where she served as a graduate assistant. In 2003, the nominee relocated to Zambia and served as Assistant Legal Counsel (Corporate Affairs) at Copperbelt Energy Corporation Plc in Kitwe, Copperbelt Province, Thereafter, she served as a Legal Counsel at the Local Authorities Superannuation Fund (LASF) in Lusaka until 2007. From 2012 to date, the nominee had been serving as a lecturer in the School of Law at the University of Zambia where she held several positions that included Assistant Dean (Undergraduate), Acting Dean and Head of Private Law Department.

She also served as a Legal Consultant at the Southern African Institute for Policy and Research (SAIPAR) since 2013. The nominee was an accomplished scholar who had extensively written peer reviewed articles on diverse subjects, but mainly focused on human rights, constitutionalism and environmental law. Given her expertise and vast experience, the nominee would enhance the operations of the HRC.

Further, the nominee had demonstrated great attributes in her legal career in various professional bodies that she served as a member. These included: Research Partner at

the Centre for Sustainable Development Law (CISDL); a Committee Member of the Environmental Lawyers of the International Law Association at the IUCN World Conservation Congress; a Member of committees on Environment, Health and Safety Law, Oil and Gas Law; African Regional Forum and Academic and Professional Development at the International Bar Association (IBA); a member of the Commonwealth Lawyers' Association (CLA); and a member of the Law Association of Zambia (LAZ).

The nominee had received numerous awards and recognition. These included an Essay Competition Award Class 'A' from the Royal Commonwealth Society and a Certificate of Merit from the Annual International Law Students Association in Washington, D C in 1998. She was also awarded the IUCN Scholarship award to study a Master of Laws (Environmental Law) at the University of Kwa Zulu -Natal in Pietermaritzburg in South Africa in 2002. Additionally, in 2007, the nominee was further awarded a Commonwealth Scholarship to study a Doctorate degree of Law (Environment Law) at the University of Manchester in the United Kingdom. In 2018, she was awarded an exemplary dedication to duty Labour Day award by the University of Zambia and in 2020, she was recognised by the Institute for African Women in Law as one of the eminent African Women Lawyers.

Clearly, the nominee had had a stellar career, and in that regard, she was eminently qualified, experienced and suitable for appointment as to serve as Vice-Chairperson of the HRC and the Government fully supported her appointment.

### (ix) **Revd Canon Emmanuel Yona Chikoya**

The nominee was born on 2<sup>nd</sup> November, 1969. He held a Diploma in Theological Studies (Religious Studies in Christian Missions) from Cambridge University through St John's Anglican Seminary in Kitwe. He also held a Bachelor of Theology and a Masters Degree in Theology from Justo Mwale University in Lusaka.

The nominee had a passion to provide holistic ministry and believed in community development that empowered people for effective and sustainable livelihoods and combating any practices and systems that oppressed the people. As a result of his vocation, he advocated for Christian ideals and principles.

During his long working career, the nominee worked as a switchboard operator at National Airports Corporation at Lusaka International Airport from 1990 to 1991. Thereafter, the nominee served as a bank clerk and supervisor B category at the Zambia National Commercial Bank Headquarters in Lusaka until 1998. The nominee also served in various positions in the Anglican Church, which included that of a Deacon, Curate and Assistant Priest at the Anglican Cathedral of the Holy Cross in Lusaka, Head of Missions and Evangelism and University Ecumenical Chaplain for the Council of Churches in Zambia, Diocesan Synod Secretary at the Anglican Diocese of Lusaka, Diocesan Training Chaplain at the Anglican Diocese in Lusaka and Parish Priest for Chawama Anglican Parish in Lusaka. Further, in 2011, the nominee served as Archdeacon for the Southern Archdeaconry for Southern and Western Provinces, a position he held until 2015. He also served as Resident City Canon at the Anglican Cathedral of the Holy Cross in Lusaka. The nominee was currently serving as the General Secretary of the Council of Churches in Zambia.

The nominee was, therefore, qualified, experienced and suitable for appointment as a Commissioner of the HRC and the Government fully supported his appointment.

## (x) Mr Tom Trevor Shamakamba

The nominee held a Bachelor of Laws degree from UNZA obtained in 1994 and was admitted to the bar in 1995. During his twenty-seven (27) year legal career, the nominee had worked in both the private and public sector. He began his career as an Intern at Jitesh Naik & Advocates in Lusaka from 1994 to 1995. Thereafter, he worked as an associate at Messrs Ellis & Company from 1995 to 1996 as well as a lecturer in Business Law at Northern Technical College (NORTEC) in Ndola. Subsequently, in 1996, the nominee served as in-house counsel for Zamtel Limited in Ndola until 2001. He was currently the Managing Partner of Shamakamba & Associates.

In the course of his career, the nominee provided *pro bono* services and that demonstrated his commitment to the preservation of human rights. The nominee was a member of the Law Association of Zambia and had served as a Council Member for eight (08) years. He had demonstrated the ability to litigate criminal and civil matters. He possessed superior research attributes as well as analytical, communication and writing skills. He developed administrative and management functions related to the practice of law and advised clients concerning business transactions, claims liability, and the advisability of prosecuting or defending lawsuits. He had also provided consultancy services to Government agencies.

The nominee was, therefore, qualified, experienced and suitable for appointment as a Commissioner of the HRC and the Government fully supported his appointment.

#### (xi) Ms Laura Miti

The nominee held a Bachelor of Arts with Education degree (English) from the University of Zambia and also possessed a Master of Arts degree in History from the University of Fort Hare in South Africa. During her distinguished working career, the nominee served as Programme Coordinator Parliamentary Liaison Programme with Caritas Zambia from 2001 to 2004. From 2010 to 2016, she served as the Public Service Accountability Monitor at Zambia Lead in Rhodes University in Grahamstown, South Africa. The nominee was currently the Executive Director of the Alliance for Community Action.

The nominee was a civil society activist who utilised social media to influence public opinion on democracy, human rights and service delivery, especially for the less privileged. She led the Yellow Card Movement against bad governance and contributed to the civil society organisation advocacy against the enactment of the Constitution of Zambia (Amendment) Bill, No. 10 of 2019. She also worked with other civic actors to mobilise and capacitate citizens on their right vote.

The nominee had received numerous awards that included Columnist award of the Year from Eastern Cape in South Africa in 2010, the Media Institute of Southern Africa Most Influential Social Media Activist award in 2016, Women's Award "Activist of the Year", in 2017, the Scottish Human Rights Defender Fellow in 2019 and the Southern African Human Rights Defender of the year from the Southern

African Human Rights Defenders Network in 2021. She was the founder and Chairperson of Kwela Trust, whose work was meant to identify and support secondary school children from vulnerable and financially constrained homes who had dropped out of school. Kwela Trust also managed one-off funds for various benefactors of charity causes.

The nominee had advocated for decriminalising certain offences. Additionally, she had advocated for community sentencing of prisoners because she believed that not every offence required a custodial sentence. She was a human rights activist who had a strong view that every person had a right to privacy regardless of their sexual orientation.

In that regard, the nominee was qualified, experienced and suitable for appointment to serve as a Commissioner of the HRC and the Government fully supported her appointment.

## (xii) Ms Christine Chama

The nominee held a Bachelor of Arts Degree in Development Studies and a Diploma in Social Work. During her distinguished working career, she had served as an Assistant Social Welfare Officer at the Social Welfare Department District Office in Kabwe. She served as the President of the University of Zambia Development Studies Association from 2019 to 2020 and was a representative of the Students Living with Disabilities at the University of Zambia. Further, in 2019, the nominee participated in the Youth Leadership Conference organised by the National Youth Development Council and attended a launch of a study focusing on Assessment of the Production, Profitability and Revenue.

The nominee possessed strong attributes of social work, community client needs, agency of purpose, cultural setting and the principle of purposeful relations. She was a first class team worker with forward thinking and excellent communication, negotiations and influencing abilities compounded by strong analytical and organisational skills. She had a deep passion for developing and planning and had expert knowledge on social challenges and strategic planning.

The nominee was appointed as an executive member of the Women and Girls with Disabilities Rights at the Zambia National Executive Committee in 2021. She was also serving as a member of the Advisory Board for Vilole Images Productions.

In that regard, the nominee was highly qualified, experienced and suitable for appointment as a Commissioner of the HRC and the Government fully supported her appointment.

## **OBSERVATIONS AND RECOMMENDATIONS**

**31.** The Committee observes that all the State security agencies did not find any adverse records against the nominees. Additionally, most of the witnesses that appeared before the Committee submitted that the nominees possessed the requisite experience and were qualified to serve in their respective positions.

The Committee notes that the appointments have been made on merit and the nominees are qualified to hold their designated positions and the Committee is confident that the nominees will discharge their duties professionally and impartially.

The Committee observes that the Constitutional requirement, in Article 259 of the Constitution, relating to gender balance and the appointment of persons with disabilities in making appointments, has been observed. In this regard, the Committee commends the Appointing Authority. However, the Committee also notes that Article 259 (1) (c) regarding taking into account youth representation in making appointments, has, to a large extent, not been adhered to. In that regard, the Committee urges the Appointing Authority to take this into consideration when making appointments in future.

Furthermore, the Committee observes that the practice by the Executive of publicly announcing appointments before the House has ratified them has the potential of prejudicing the ratification process and should be discouraged.

The Committee makes the following specific observations regarding each of the nominees: (i) Judge Prisca Matimba Nyambe (Rtd)

The Committee notes that the nominee has served as an adjudicator for over ten (10) years and that, before her retirement, she was a Judge of the High Court. Further, the nominee has extensive knowledge in international best practices having served in international organisations and as an Observer for Presidential and Parliamentary Elections in the region.

The Committee further observes that given her experience both at the Bar and the Bench, in Zambia and Zimbabwe, and having exhibited professionalism and impartiality in her previous roles, the nominee is suitably qualified to be a Member of the JCC. The Committee, in this regard, supports the ratification of her appointment to serve as a Member of the JCC.

## (ii) Mr Chad Himoonga Muleza

The Committee notes that, with over forty-one (41) years experience as a legal practitioner, the nominee possesses the academic qualifications and experience required to serve as a Member of the JCC.

Some witnesses expressed concern that the nominee was part of the UPND legal team. The Committee, however, observes that this does not disqualify the nominee from appointment because his relationship with the party was a professional one based on the client and legal practitioner relationship.

The Committee is, therefore, satisfied with the nominee's credentials and supports his ratification as a member of the JCC.

## (iii) Mr Musa Mwenye SC

The Committee observes that the nominee possesses the requisite academic qualifications and experience for appointment as Chairperson of the Anti-corruption Commission Board as provided under the Anti-Corruption Act. Having served both as Solicitor-General and

Attorney General of the Republic of Zambia, the Committee has no doubt that the nominee will serve the Commission with professionalism and impartiality.

The Committee is confident that the Commission will benefit greatly from his knowledge and experience and, therefore, supports his ratification.

## (iv) Mrs Irene Musonda Chongo Lamba

The Committee observes that the nominee possesses over twenty-eight (28) years' experience in the legal fraternity. Additionally, she has vast exposure and skills in civil and criminal law obtained from both the private and public sector. While in the public sector, the nominee served as Director-General of the ACC. The Board will, therefore, benefit from her expertise.

The Committee notes that the nominee once served as Acting Director-General of the ACC and that during that period, she was also a partner in a law firm. As a result of this, she was charged with three (3) offences; two (2) under the Penal Code and one (1) under the Anti-Corruption Act. Under the Penal Code, she was charged with breach of trust and disobedience of statutory duty while under the Anti-Corruption Act, she was charged with abuse of authority of office. It was, however, found that the requirement for an office holder to make a declaration of interest related to the position of Director-General. Therefore, since her substantive position was Deputy Director-General, she was not required to disclose interest. Consequently, the charges under the Penal Code were dismissed and she was acquitted of the one under the Anti-Corruption Act. In view of this, there is no legal impediment to her appointment to the ACC Board.

The Committee is confident that the nominee is suitably qualified and experienced and that her experience will add value to the composition of the Board. Therefore, the Committee supports the ratification of her appointment.

## (v) **Dr Henry Bwanga Mbushi**

The Committee notes the nominee's professional qualifications and his vast experience in the legal domain both locally and internationally. The Committee also notes his wealth of knowledge having served as Deputy Ambassador to Belgium where he was responsible for administration of the embassy and attending meetings with European Union representatives.

The Committee notes that some witnesses expressed concern that the nominee was part of the UPND legal team. They were of the view that this was in conflict with paragraph 2 of the Schedule to the Anti-Corruption Act, which does not allow a person holding a position in a political party to be appointed to the Anti-Corruption Commission Board. The Committee, however, observes that while the nominee may have been on the UPND legal team, he was not a holder of an office in the party as envisaged by the Anti-Corruption Act. The nominee, therefore, qualifies for appointment to the ACC Board.

The nominee brings a unique balance to the Commission due to his vast experience from the legal fraternity and is suitably qualified and experienced to serve as a member of the ACC Board. The Committee, therefore, supports the ratification of his appointment.

## (vi) **Dr O'brien Kaaba**

The Committee notes that the nominee is a distinguished academician and consultant with diverse experience. He has been actively involved in research and consultancies in areas such as constitutional law, administrative law, governance, legal process, human rights and humanitarian law. In addition, through trainings organised by the Anti-Corruption Resource Centre and the Norwegian Embassy, the nominee has gained knowledge and skills in corruption prevention

The Committee is, therefore, satisfied that the nominee is suitably qualified and experienced to serve as a member of the ACC Board and supports the ratification of his appointment.

## (vii) Mr Gilbert Andford Phiri

The Committee notes that the nominee has the requisite academic qualifications and experience to serve as Director-General of the ACC, given his experience as a legal practitioner and his service on different boards.

The Committee further notes that the nominee was part of the legal team for the UPND. The Committee, however, observes that, as a member of the team, his relationship with the party was a professional one of client and lawyer. It, therefore, should not prevent him from appointment as Director -General of the ACC. The Committee also notes that the nominee has since relinquished his representation of the UPND party and his position on the Energy Regulation Board to avoid appearing conflicted.

The Committee is, therefore, satisfied with the nominee's credentials and supports the ratification of his appointment as Director-General of the ACC.

## (viii) Dr Pamela Towela Sambo

The nominee is qualified to hold high judicial office having been a legal practitioner for over twenty (20) years. Additionally, she has vast experience in academia and legal research. The nominee has a stellar record in terms of her academics in the legal profession. In addition, she has exceptional legal skills in human rights and environmental law and her appointment will create gender balance on the HRC Board.

The Committee is satisfied that the nominee is highly qualified and has the necessary skills and expertise to serve as a Commissioner of the HRC Board and supports the ratification of her appointment.

## (ix) Revd Canon Emmanuel Yona Chikoya

The Committee notes that the nominee is a renowned clergyman with a demonstrated history of working in the religious institutional industry for over twenty (20) years. The Committee further notes that the nominee has experience in human rights and corporate governance through the various Boards he serves on.

The Committee is also confident that the nominee's appointment promotes diversity in the composition of the HRC Board. The nominee is, therefore, suitably qualified to serve on the HRC Board and the Committee supports the ratification of his appointment.

## (x) **Mr Tom Trevor Shamakamba**

The nominee possesses superior research work, analytical, communication and writing skill attributes. Further, he has performed administrative and management functions related to the practice of law.

The Committee is, therefore, satisfied that the nominee is highly qualified and has the necessary skills and expertise to serve as Commissioner of the HRC Board and supports the ratification of his appointment.

## (xi) Ms Laura Miti

The Committee observes that the nominee is a well-known human rights advocate with extensive experience in civil society activism. Many accolades and awards have been bestowed upon the nominee for her activism and passion for human rights and good governance. These include Southern African Human Rights Defender of the Year (Southern African Human Rights Defenders Network), 2021, Scottish Human Rights Defender Fellow, Activist of the Year 2017, and Most Influential Social Media Activist of 2016.

The Committee observes that some witnesses were concerned about the nominee's position on LGBT rights, which were a criminal offence in Zambia. The nominee explained that her opinions on LGBT rights were based on the denial of a person's right to privacy and that she was not advocating the amendment of the law to allow for LGBT rights.

The Committee is satisfied that the nominee is highly qualified and has the necessary skills and expertise to serve as Commissioner of the HRC Board and supports the ratification of her appointment.

#### (xii) Ms Christine Chama

The nominee is a social scientist with a bias towards social work. She has experience as an advisory Board member and also served as President of the University of Zambia Development Studies Association as well as the Students Living with Disabilities representative. In addition, as a differently abled person, the nominee will provide the perspective of differently abled persons and other marginalised groups to the HRC. The appointment of the nominee also adds a gender dimension to the membership of the HRC.

The Committee, after due and thorough consideration, analysis and evaluation of the written and oral submissions presented to it by the witnesses and the interview with the nominees, is of the considered view that all the nominees are eminently qualified and possess the requisite competences to serve in their respective positions.

The Committee, therefore, recommends that the House ratifies the Presidential appointment of Judge Prisca Matimba Nyambe (Rtd) and Mr Chad Himoonga Muleza to serve as members of the Judicial Complaints Commission (JCC), Mr Musa Mwenye SC, Mrs Irene Musonda Chongo Lamba, Dr Henry Bwanga Mbushi and Dr O'brien Kaaba to serve as Chairperson and members of the Anti-Corruption Commission Board, respectively, and Mr Gilbert Andford Phiri to serve as Director-General of the Anti-Corruption Commission (ACC), and Dr Pamela Towela Sambo, Revd Canon Emmanuel Yona Chikoya, Mr Tom Trevor Shamakamba, Ms Laura Mary Miti and Ms Christine Chama to serve as Vice-Chairperson and Commissioners of the Human Rights Commission (HRC) respectively.

### CONCLUSION

**32.** The Committee wishes to express its gratitude to all the stakeholders who appeared before it and tendered both oral and written submissions. The Committee also appreciates your guidance, Madam Speaker, and the services rendered by the Office of the Clerk of the National Assembly during its deliberations.
