PARLIAMENTARY SELECT COMMITTEE APPOINTED TO SCRUTINISE THE PRESIDENTIAL APPOINTMENT OF HON JUSTICE DR MUMBA MALILA, SC, TO SERVE AS CHIEF JUSTICE AND MR VINCENT BLACKSKIN MALAMBO, SC, TO SERVE AS A MEMBER OF THE JUDICIAL COMPLAINTS COMMISSION (JCC)

Madam,

The Parliamentary Select Committee was appointed on 26th November, 2021, to scrutinise the Presidential appointment of Hon Justice Dr Mumba Malila, SC, to serve as Chief Justice and Mr Vincent Blackskin Malambo, SC, to serve as a member of the Judicial Complaints Commission (JCC).

The appointment of Hon Justice Dr Mumba Malila to serve as Chief Justice is made pursuant to Article 140 (a) of the Constitution of Zambia, Chapter 1 of the Laws of Zambia, which provides as follows:

"140. The President shall, on the recommendation of the Judicial Service Commission and subject to ratification by the National Assembly, appoint the—

(a) Chief Justice;"

The appointment of Mr Vincent Blackskin Malambo, SC, to serve as a member of the Judicial Complaints Commission is made pursuant to Section 20 of the Judicial Code of Conduct Act No. 13 of 1999, which provides as follows:

- "20. (1) There is hereby constituted the Judicial Complaints Authority which shall consist of five members who have held or are qualified to hold high judicial office.
 - (2) The members of the Authority shall be appointed by the President subject to ratification by the National Assembly."

TERM OF REFERENCE

2. The Term of Reference of the Committee was to scrutinise the Presidential appointment of Hon Justice Dr Mumba Malila, SC, to serve as Chief Justice and Mr Vincent Blackskin Malambo, SC, to serve as a member of the Judicial Complaints Commission (JCC).

MEMBERSHIP

3. The Committee comprised the following Members:

Mr C Andeleki, MP, Chairperson; Ms M Phiri, MP, Vice-Chairperson; Mrs C Halwiindi-Phiri, MP; Mr K Simunji, MP; Mrs E Munashabantu, MP; Mr A Kasandwe, MP; Mr K S Michelo, MP; Mr G K Chisanga, MP; Mr I Wamunyima, MP; and Mr J Murebwa, MP.

MEETINGS OF THE COMMITTEE

4. The Committee held a total of six (6) meetings during the period 30th November, 2021 to 16th December, 2021. At its First Meeting held on Tuesday, 30th November, 2021, the Committee elected, Mr C Andeleki, MP, as Chairperson and Ms M Phiri, MP, as Vice-Chairperson.

PROCEDURE ADOPTED

5. The Chief Justice is the head of the Judiciary and is responsible for the general administration of the Judiciary. The Chief Justice ensures that judges and judicial officers operate independently, is responsible for the conduct of judges and the administration of justice.

The Judicial Complaints Commission is a body established under Article 236 of the Constitution to enforce the code of conduct for judges and judicial officer and ensure that they are accountable to the people for the performance of their functions. In that regard, members of the JCC receive, investigate and hear complaints of misconduct against judges and judicial officers, and make recommendations on the appropriate action to be taken.

In view of the above, both the Chief Justice and members of the Judicial Complaints Commission play a pivotal role in the dispensation and administration of justice in the country. Their offices are, therefore, critical to good governance and the rule of law.

Given the importance of the offices to which the nominees are being appointed, the Committee resolved that only competent persons with the requisite qualifications and experience should serve in the offices. Further, the Committee resolved that the persons should be of unquestionable integrity, diligence, eminence, and sound character and, above all, committed to the promotion of good governance, the rule of law and serving the people of Zambia.

Therefore, the Committee carefully selected the witnesses to assist it in the scrutiny of the nominees. The Committee requested memoranda from the state security agencies, relevant professional bodies and the Appointing Authority. The witnesses also appeared before the Committee to make their oral submissions. Further, the Committee assessed the suitability of the nominees to serve in the various appointments by scrutinising, in detail, their *curricula vitae* and the information submitted to the Committee by the witnesses.

SUBMISSIONS BY STATE SECURITY AGENCIES

ZAMBIA POLICE SERVICE (ZP)

6. The Senior Assistant Commissioner of Police submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. He informed the Committee that ZP had verified the nominees' academic qualifications with the Examinations Council of Zambia and the schools they had attended.

The Senior Assistant Commissioner of Police informed the Committee that a search conducted by its Criminal Records Department had not revealed any criminal or adverse record against the nominees. In that regard, ZP did not have any objection to the nominees' appointment.

ANTI-CORRUPTION COMMISSION (ACC)

7. The Acting Director-General of the ACC submitted on the personal, educational and professional background of the nominees as contained in their *curricula vitae*.

The Acting Director-General informed the Committee that his submission was based on the ACC's mandate set out in the Anti-Corruption Act No. 3 of 2012. In that regard, the submission did not cover offences committed under any other law. He explained that the ACC used a computerised database called the Case Management System to conduct its searches. He added that the database stored information relating to any investigations that the ACC had handled. This included information on a suspect's details and the nature of the allegation.

The Acting Director-General submitted that a search on the ACC's database did not yield any adverse record against the nominees. In that regard, the ACC supported the appointment of the nominees to serve in the positions they had been appointed to.

DRUG ENFORCEMENT COMMISSION (DEC)

8. The Director-General submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*.

The Director-General informed the Committee that DEC searched its database to determine whether a person had contravened the Narcotic Drugs and Psychotropic Substances Act No 35 of 2021 or the Prohibition and Prevention of Money Laundering Act No.44 of 2010. He submitted that a search conducted on the nominees had not yielded any adverse record against them. He added that the nominees were suitably qualified for appointment to serve as Chief Justice and member of the Judicial Complaints Commission, respectively, and in that regard, DEC supported their appointment.

SUBMISSIONS BY PROFESSIONAL BODIES/STAKEHOLDER INSTITUTIONS

FINANCIAL INTELLIGENCE CENTRE (FIC)

9. The Director-General informed the Committee that FIC considered the legal framework that provided for the appointment of the Chief Justice and members of the JCC. Thereafter, she submitted on each of the nominees as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee met the criterion for appointment to the office of Chief Justice of the Republic of Zambia. He had immensely contributed to the growth of Zambia's jurisprudence through his various roles and publications.

In addition, a perusal of the institution's database did not reveal any adverse information that would preclude the nominee from being appointed as Chief Justice. Further, there was no pending suspicious transaction report or criminal record pertaining to the nominee. FIC, therefore, supported his appointment to serve as Chief Justice of the Republic of Zambia.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee met the criterion for appointment to serve as a member of the JCC. A perusal of FIC's database did not reveal any adverse information that would preclude the nominee from being appointed a member of the JCC. Further, there was no pending suspicious transaction report or criminal record pertaining to the nominee. FIC, therefore, supported his appointment to serve as a member of the JCC.

HUMAN RIGHTS COMMISSION (HRC)

10. The Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. She further submitted on each of the nominees as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee had an impeccable professional and academic track record, having practised as an advocate for over thirty years. He was an eminent scholar, legal practitioner and a distinguished judge of the Supreme Court. Further, his qualifications and experience would help build the required public confidence in the Judiciary.

The nominee was capable of performing the duties of Chief Justice as seen from the quality of judgements he had delivered in the Supreme Court and the expedience with which he had delivered them. Further, as an author who had demonstrated boldness and fearlessness in his writings, which included criticising the Judiciary, it was hoped that he would be able to promote the development of jurisprudence in Zambia. As a recipient of the Human Rights Commission award in recognition of his immense contribution to the cause of human rights both in Zambia and, abroad, the nominee would ensure that judicial authority was exercised in a just manner, thereby promoting accountability. In that regard, he was qualified for appointment as Chief Justice.

The HRC had no adverse report against the nominee and, therefore, supported his appointment.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee possessed the requisite academic and professional qualifications to serve as a member of the JCC. He possessed vast experience as a legal practitioner, mediator and lecturer who had taught Professional Ethics and Conduct at the Zambia Institute of Advanced Legal Education (ZIALE). The nominee's good understanding of professional ethics and conduct would add value to the JCC.

The HRC did not have any adverse report against the nominee and, therefore, supported his appointment.

SOUTHERN AFRICAN CENTRE FOR THE CONSTRUCTIVE RESOLUTION OF DISPUTES (SACCORD)

11. The Executive-Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. He further submitted on each of the nominees as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee was eligible to hold the position of Chief Justice because he had a clear track record within the judicial system.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee was eligible to be a member of the JCC. The nominee possessed a clear track record as a legal practitioner and had vast knowledge in professional ethics and conduct, considering having lectured the course at ZIALE.

SACCORD had not come across any adverse information against the nominees during its investigations and, therefore, recommended the ratification of their appointments.

FOUNDATION FOR DEMOCRATIC PROCESS (FODEP)

12. The Executive Director submitted on the personal, educational and professional background of the nominees as stated in their *curricula vitae*. He submitted on each nominee as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee was a highly accomplished legal practitioner and his appointment would raise public confidence in the Judiciary. The nominee possessed vast experience in the legal fraternity, having served twice as Attorney-General. Additionally, the nominee was currently serving as a judge of the Supreme Court. The nominee's appointment was, therefore, well deserved.

FODEP supported the appointment of the nominee as Chief Justice because he would add value to the Judiciary.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee had vast experience and expertise, which he had acquired during his thirty-three (33) years of law practice. Further, that the nominee was a member of the Legal Practitioners Committee (LPC) of the Law Association of Zambia (LAZ), a body that was responsible for checking the conduct of legal practitioners.

The nominee also served as Special Assistant to the President for Political and Legal Affairs and also served as Minister of Legal Affairs. In that regard, he was suitably qualified for appointment as a member of the JCC.

In that vein, FODEP had no objection to the nominee's appointment.

JUDICIAL COMPLAINTS COMMISSION (JCC)

13. A Member of the JCC informed the Committee that the mandate of the JCC was to provide judicial oversight. The Member of the JCC then submitted on the personal, educational and professional background of the nominee for the position of Chief Justice as set out in his *Curriculum vitae*. She then submitted on the nominee as set out below.

Hon Justice Dr Mumba Malila, SC

The nominee had twice served as Attorney-General from, 2006 to 2009 and from 2011 to 2014. The nominee was appointed as a judge of the Supreme Court of Zambia in July, 2014. While in the Supreme Court, he had demonstrated that he was an impeccable judge with a good track record. He had also acquired vast experience in the administration of justice The JCC was, therefore, confident that the nominee would assist in ensuring that matters were disposed of without any unreasonable delays.

The Member submitted that the JCC had no adverse record against the nominee because no complaint had been lodged against him. Therefore, the JCC supported his appointment to serve as Chief Justice.

LAW ASSOCIATION OF ZAMBIA (LAZ)

14. The President of LAZ stated that the Council of LAZ, with the help of State Counsel, had deliberated on the suitability of the nominees, and had resolved to support them because they qualified for appointment to their respective positions. He, thereafter, submitted on each of the nominees as set out below.

(i) Hon Justice Dr Mumba Malila, SC

LAZ was cognisant of the constitutional provision on the appointment of the Chief Justice. LAZ was of the view that a person who occupied the office of Chief Justice should not only have integrity and a track record of delivering judgments, but also be a good administrator. The nominee was a person of integrity, had a track record of delivering judgments and was also a good administrator.

In addition, the nominee was a respected human rights lawyer, who had provided *pro bono* services for the indigent facing criminal charges in Zambia. He was also an experienced jurist who had written extensively on judicial independence and Zambia's jurisprudence. Being a critic of the Judiciary, LAZ expected the nominee to improve the administration of justice by addressing the challenges he had observed. The nominee had also mastered the art of writing judgments, which would assist him diligently discharge the functions of Chief Justice.

The nominee had also twice served as Attorney-General of the Republic Zambia and ex-officio member of the Zambian Cabinet. During his tenure as Attorney-General, the nominee served as a member of various public institutions. The nominee also served on some human rights bodies and was once the Honorary Secretary of LAZ.

LAZ was, thus, confident that based on his qualifications, experience, character and demeanour the nominee would effectively discharge the functions of Chief Justice. LAZ, therefore, fully supported his appointment.

(ii) Mr Vincent Blackskin Malambo, SC

The JCC required men and women of candour, integrity, courage and sobriety to ensure that the institution was not viewed as weak in the execution of its mandate. The nominee possessed and exhibited the said values. The nominee was a very senior legal practitioner who qualified to be appointed as a judge of any of the superior courts and, therefore, was suitable for appointment to serve as a member of the JCC.

THE ZAMBIA QUALIFICATIONS AUTHORITY (ZAQA)

15. The Chief Executive Officer submitted that ZAQA was established to develop and implement a national qualifications framework and institute measures to ensure that standards and registered qualifications were internationally comparable. She added that, as part of its mandate, ZAQA was responsible for independently validating and evaluating all qualifications for recognition in Zambia.

She further submitted that the process of validating and evaluating qualifications included the following three stages:

- (a) establishing the accreditation status or recognition of the awarding body that conferred the qualification. This stage sought to affirm that the awarding body, be it local or foreign, had the legal mandate or delegated authority from central government or from a government agency to award nationally recognised and quality assured qualifications;
- (b) confirmation from the awarding body that the qualification was, indeed, genuinely awarded to the holder of the qualification; and
- (c) establishing the level, on the Zambia Qualifications Framework (ZQF), at which a particular qualification should be recognised, considering set standards of competence for each level of qualification. She added that the Zambia Qualifications Framework was a single integrated system which comprised three coordinated qualifications sub-frameworks for
 - (i) general education;
 - (ii) trades and occupations; and
 - (iii) higher education.

The Chief Executive Officer submitted that having considered the legal provisions relating to the nominees' appointments, ZAQA subjected the qualifications of the nominees to the evaluation and validation process. She stated that the results were as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee's qualifications were authentic and awarded to him by credible institutions.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee's qualifications were authentic and awarded to him by credible institutions.

The Chief Executive Officer concluded her submission by stating that ZAQA was satisfied with the nominees' qualifications and in that regard, they were suitable for appointment to their respective positions.

JUDICIAL SERVICE COMMISSION (JSC)

16. The Chairperson submitted on the personal, educational and professional background of the nominee for appointment as Chief Justice as stated in his *curriculum vitae*.

He stated that at national level, the nominee had blended legal practice and academia as he had served with distinction, in various public and private sector positions. The Chairperson informed the Committee that the nominee had an impeccable record as an astute adjudicator and

administrator. He had demonstrated impartiality, good leadership, interpersonal skills, competence, integrity and professionalism.

The Chairperson explained that the nominee possessed the appropriate qualifications and experience to occupy the office of Chief Justice of the Republic of Zambia.

The Chairperson informed the Committee that the Judiciary was faced with a number of challenges such as understaffing, missing of files, delayed judgments and lack of proper infrastructure, especially at Local Court level. In that regard, the JSC was confident that, with the nominee's background, especially as former Attorney-General, he possessed sufficient experience to head the Judiciary. Further, his work culture had accorded him the ability to galvanise his colleagues and garner their support in performing various tasks assigned to him.

In conclusion, the Chairperson submitted that the JSC had no reservations in recommending the ratification of the nominee as he satisfied the legal requirements for appointment as Chief Justice.

SUBMISSIONS BY THE NOMINEES

(i) Hon Justice Dr Mumba Malila, SC

17. The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

He informed the Committee that he had twice served as Attorney-General and that part of his responsibility as Attorney-General involved supervising lawyers under the Ministry of Justice. In view of that, he had gained administrative experience. He added that his experience as Assistant Dean Post-Graduate and Research at the University of Zambia had also enabled him to acquire administrative experience.

The nominee submitted that having served in different portfolios locally, regionally and internationally, he had acquired the necessary exposure that would aid him in carrying out the functions of Chief Justice, if ratified. In terms of his ability to manage both administrative and adjudicative responsibility, he informed the Committee that at the Supreme Court, the Chief Justice's work load was less than that of other judges. In that regard, the Chief Justice had time to attend to administrative matters. As a result, the administrative component of his office would not be affected. He added that he was eager to improve as an individual to enhance his capacity to multi-task.

The nominee submitted that the biggest challenge facing the Judiciary was the lack of public confidence in it. In view of this, he would strive to redeem the Judiciary's image, especially with regard to the work culture and attitude among adjudicators. Further, the nominee stated, that if ratified, he would introduce reforms to ensure the prompt delivery of judgments, and realign or restructure the courts. He would also strengthen the integrity committee and closely supervise the courts in accordance with the functions of the office of Chief Justice.

(ii) Mr Vincent Blackskin Malambo, SC

18. The nominee informed the Committee about his personal, academic and professional background as contained in his *curriculum vitae*.

He informed the Committee that he had over thirty-three (33) years experience in the legal profession. He submitted that he was once a politician and had served as Minister of Legal Affairs. He explained that he had been a resource person for many judicial colloquies during which he covered topics on judicial ethics and had served on the Legal Practitioners Committee of LAZ for three terms.

The nominee informed the Committee that he was aware that one of the causes of delayed justice delivery by the courts was due to loss of court records. He explained that, that was mainly attributed to files being kept in the registry and not by the judges. In that regard, the nominee stated that it was imperative that the JSC took administrative action to ensure that erring officers were held accountable for losing court records.

The nominee also informed the Committee that he had noted that the procedure for the appointment of judges posed a challenge on the improvement of the judicial system in Zambia. He, therefore, proposed that the appointing authority needed to adopt a more rigorous process of selection, whereby appointments were made on merit.

The nominee submitted that he was aware that the independence of the Judiciary was a challenge and, therefore, if ratified, he would ensure that judges operated independently. He, however, pointed out that he would not permit the JCC to be used as an appellate court of judicial decisions. He added that the only time that the JCC would review judicial decisions would be when it was evident that the decisions were influenced by external factors. The nominee concluded his submission by stating that although he may not be sufficiently qualified to be Chairperson, he was of the view that he was sufficiently qualified to be a member of the JCC.

SUBMISSION BY THE APPOINTING AUTHORITY

19. The Acting Minister of Justice appeared before the Committee on behalf of the Appointing Authority and submitted on the nominees' educational and professional qualifications. He highlighted the individual achievements of each nominee with regard to their respective careers. He stated that the nominees had long, unbroken service records and had attained international recognition. Therefore, he was confident that the nominees would not misconduct themselves, if ratified. The Hon Minister further informed the Committee that based on the *curriculum vitae* of the nominees, they possessed the requisite experience and that the Appointing Authority was satisfied that they were suitable to serve in the positions they had been appointed to.

The Hon Minister submitted on each nominee as set out below.

(i) Hon Justice Dr Mumba Malila, SC

The nominee was born on 16th April, 1964. He held a Bachelor of Laws (LLB) degree from the University of Zambia and was admitted to the Zambian Bar in 1989. The nominee also possessed various post-graduate qualifications including a Master of Laws (LLM) degree from the University of Cambridge in England and a Doctorate of Laws degree from the University of Pretoria. He also held a Diploma in International Commercial Arbitration from the Chartered Institute of Arbitration in London and a Post-graduate certificate in Human Rights from the Rene Casin Institute of Human Rights, Strasbourg, France.

During his thirty-two (32) year legal career, the nominee served in various positions in the legal profession of Zambia. He served as a lecturer and tutor at the University of Zambia Law School and served in various positions, which included Board Secretary of the Zambia Law Journal and Legal Advisor to the University of Zambia Administration from 1991 to 1993.

The nominee served as the Chairperson of the Human Rights Commission of Zambia from 2004 to 2006 and was conferred with the rank and dignity of State Counsel in December, 2006. Thereafter, he was appointed twice as Attorney-General, and served as an *ex-officio* member of the Zambian Cabinet under three (3) former Presidents. During his tenure as Attorney-General, he served as a Chairperson and member of various other public bodies and institutions.

With regard to the nominee's legal practice, he had practised as a legal practitioner under the law firm Christopher Russell Cook & Co and was the founder and Managing Partner of the law firm, Phoenix Partners, which was later renamed Mumba Malila & Partners.

The nominee served as Commissioner of the African Commission on Human and Peoples' Rights and further served as the Vice-Chairperson of the Commission from October, 2006 to November, 2011. In October, 2020, the nominee was appointed as a member of the United Nations Working Group on Arbitrary Detention. The nominee was also a Supreme Court judge, a position he has held from 2014 to date and was the current Chairperson of the Chief Justice's Advisory

Committee on Court Operations. Further, the nominee had authored various publications on various legal topics.

The nominee was, therefore, highly qualified, experienced and suitable for appointment as Chief Justice of the Republic of Zambia and the Government fully supported his appointment.

(ii) Mr Vincent Blackskin Malambo, SC

The nominee was born in 1959. He held a Bachelor of Laws Degree from the University of Zambia obtained in 1983 and a Legal Practitioners Qualifying Postgraduate Certificate, obtained in 1984.

During his thirty-seven (37) year legal career, the nominee had served in different capacities both in the public and private sector. He had, among others, served as Assistant Counsel at Namukamba Chambers from 1984 to 1986, before joining Mhango & Company as a Managing Partner. During his tenure at Mhango & Company, the nominee garnered experience in various fields of law, including company foundations, legal, business and fiscal advice, debt swaps and litigation.

The nominee also served as Special Assistant to the President for Political and Legal Affairs from 1992 to 1995. Thereafter, he was appointed Minister of Legal Affairs (now Minister of Justice), a position he held from 1996 to 2001. During that time, the nominee was extensively involved in a number of legislative, policy and regulatory developments. Additionally, the nominee rendered a number of opinions to lead banks, non-governmental organisations and various law firms, on a referral basis. He also continued to litigate many lawyer-referred cases in the superior courts. The nominee had served as a member and chairperson of various public and private bodies and was currently the principal partner at Malambo and Company.

During the course of his illustrious career, the nominee contributed to the development of law in Zambia and was conferred with the honour and dignity of State Counsel in October, 2002.

The nominee was, therefore, highly qualified, experienced and suitable for appointment as a member of the JCC and the Government fully supported his appointment.

OBSERVATIONS AND RECOMMENDATIONS

20. The Committee observes that all the State Security agencies did not find any adverse records against the nominees. Additionally, all the witnesses that appeared before the Committee submitted that the nominees possessed the requisite qualifications and experience and were eminently qualified to serve in the positions to which they had been appointed. In that regard, they supported their appointments.

The Committee notes that Article 259 (1) (b) of the Constitution requires that, in making appointments to public offices, unless it is not practicable to do so, fifty percent of each gender should be appointed. The Committee observes that both the nominees presented for ratification are male. Therefore, this constitutional requirement has not been adhered to. In that regard, the Committee urges the Appointing Authority to take this into consideration when making appointments in the future.

The Committee further observes that the practice by the Executive of publicly announcing appointments before they have been ratified by the House has the potential to prejudice the ratification process and should be discouraged.

The Committee made the following specific observations regarding each of the nominees:

(i) Hon Justice Dr Mumba Malila, SC

The Committee notes that the nominee has had a stellar career as an academician, a legal practitioner, both in private and public practice, and as a judge. While in academia, the nominee served as Acting Dean of the University of Zambia Law School and as Assistant Dean Post-Graduate and Research. He has practised as a legal practitioner for over thirty (30) years, and as a judge of the Supreme Court since 2014. He has further served twice as Attorney-General, where he was the Chief Legal advisor to the Government and an exofficio member of Cabinet. As Attorney-General, he was also the head of the Zambian Bar. In 2006, the nominee was conferred with the rank and dignity of State Counsel. The nominee served as the Chairperson of the Human Rights Commission of Zambia from 2004 to 2006. He was a Commissioner of the African Commission on Human and Peoples' Rights from 2005 to 2011, where he rose to the position of Vice-Chairperson of the Commission. While in the Judiciary, he served as Chairperson of the Editorial Board of the Zambia Law Reports and Chairperson of the Committee on the Operationalisation of the Constitutional Court and Court of Appeal. He is currently the Chairperson of the Committee on Court Operations. The Committee observes that the nominee has also published books and scholarly articles on various subjects, including on the independence of the Judiciary. The nominee is, therefore, suitably qualified and experienced to serve as Chief Justice.

(ii) Mr Vincent Blackskin Malambo, SC

The Committee observes that the nominee is a seasoned legal practitioner with thirty-seven (37) years post-admission experience. The Committee notes that the nominee has served in both public and private institutions. He served as Special Assistant to the President for Political and Legal Affairs from 1992 to 1995 and later Minister of Legal Affairs from 1996 to 2001. In 2002, the nominee was conferred with the rank and dignity of State Counsel. The Committee further notes that the nominee previously lectured Professional Ethics and Conduct at ZIALE and is currently a member of the Legal Practitioners Committee of LAZ, which handled complaints against lawyers.

The Committee, is, therefore, satisfied that the nominee possesses the requisite qualifications and experience and is suitable for appointment as a member of the JCC.

The Committee, after due and thorough consideration, analysis and evaluation of the written and oral submissions presented to it by the witnesses and the interview with the nominees, is of the considered view that both nominees are eminently qualified and possess the requisite competences to serve in the positions to which they have been appointed.

The Committee, therefore, recommends that the House ratifies the Presidential appointment of Hon Justice Dr Mumba Malila, SC to serve as Chief Justice and Mr Vincent Blackskin Malambo, SC, to serve as a member of the JCC.

CONCLUSION

21. The Committee wishes to express its gratitude to all stakeholders who appeared before it and tendered both oral and written submissions. The Committee also appreciates your guidance, Madam Speaker, and the services rendered by the Office of the Clerk of the National Assembly during its deliberations.
